Provide a safe and efficient transportation system for the traveling public, while promoting economic development and preserving the environment of New Mexico.


Department of Transportation, by the numbers:

- More than 2,500 employees
- Budget for FY23 est. at \$1.8 billion
- 90 active projects totaling more than \$1.2 billion
- 16 rest areas
- 82 patrols
- 12,272 centerline lines of highway infrastructure statewide
- 34 construction crews
- 28 construction offices

Organizational Leadership



In the past year, the agency has replaced a retired Dep. Sec. and hired a second to oversee agency operations. In total, the senior leadership team includes 12 managers.



Agency Personnel



Currently, the agency has a vacancy rate of 20% which accounts for about 500 vacancies statewide. Increased vacancy rates in D5 and within the Infrastructure team points to the need for competitive pay and critical pipeline development.

Organizational Priorities



The current leadership structure provides opportunities to align key functions and enhance oversight for large projects and moving toward an enhanced data-driven approach to all core functions.

Legislative Implementation



In 2023, the NM Legislature and Governor enacted several measures that require NMDOT support and oversight. These measures will be reported on throughout the 2023 interim.

Focus Areas:

- Allocate section 9 resources to the identified 11 priority projects
 - Identify maintenance priorities
- Prepare to properly distribute \$30 million in local airport capital upgrades
- Plan for the oversight of the Transportation Regulation Division within the PRC
- Work with partners to identify a strategic approach to increase tax distributions
- Work with partners to identify a strategic approach to an increase in EV use and fuel tax replacement
- Establish a strong understanding of the agency's deferred maintenance needs and secure capital outlay support
- Explore recurring GF allocations to support ongoing increases in personnel costs
- Establish a strategy and local toolkits for embracing a Vision Zero approach to reducing fatalities on NM roadways
- Establish a data-driven approach to funding STIP and TAMP priorities
- Develop/implement policy for ROW use in exchange for broadband access

Other Core Functions



In addition to roadway maintenance and construction, the NMDOT provides leadership over a various number of significant responsibilities related to transportation, passenger safety and local/tribal infrastructure development.
