

The Need for a Strategic River Reserve in New Mexico



History & Key Goals

- Proposed 2003, enacted 2005
- Keep some more water in New Mexico's rivers
- Avert conflict including expensive litigation – over endangered species and interstate compacts



Lessons Learned

- It can work!
 - The Strategic Water Reserve has successfully cooled conflicts over the Pecos Bluntnose Shiner
 - Lease of 20,000 acrefeet a year from the Jicarilla Apache nation on the San Juan River shows potential for major benefits
- However, two challenges have limited the Strategic Water Reserve's positive impact:
 - 1) Lack of consistent funding
 - 2) Lack of capacity within the agency to make the most of this tool

History of Appropriations to the Strategic Water Reserve

Other Funding Challenges

- Even when funding is available for the Strategic Water Reserve, it has often come with constraints that have limited effectiveness, such as:
 - Must be spent within a relatively short period of time
 - Problem: it often takes multiple years to complete a water rights transaction and the seller or lessor needs to be confident that the money will be there when the deal closes
 - Only allowed to be used for purchases, not long-term leases
 - Problem: in some critical areas, like the Middle Rio Grande, leases are the best option available



Capacity Challenges

- Right now, the only ISC staff looking at the Strategic Water Reserve are the individual river basin managers
- No one is taking a statewide perspective, looking for opportunities to make the most of this valuable tool
- Basin managers have many responsibilities and may not have the bandwidth to seek out and engage in complex water rights transactions



Legislative Recommendations

- Inject \$15 million in one-time money into the Strategic Water Reserve
 - Put in enough money to demonstrate the true potential of this tool
 - This funding needs to have a long time frame and flexible uses
- Fund 1-2 FTEs at the ISC specifically dedicated to the Strategic Water Reserve and related initiatives
 - This capacity increase, along with the investment of funding, can help the Strategic Water Reserve function effectively as a tool for averting conflict over New Mexico's rivers
