


NM Game Commission Certification of Non-Navigable Waters - Troutstalker Ranch

- Property owner has constructed a habitat restoration project in the Rio Chama-Chamita floodplain/channel.
- Property owner has constructed riverside lodging and employed an in-house fishing guide; charges daily fees for access.
- Two cross-river cables (indicated on this map) with DGF and other "no trespass" signage attached require boaters to make short portages across private property at runnable flows.
- Title to property arose from the Merced de Tierra Amarilla grant, which historically provided relatively open fishing access to land grant heirs, residents of the Chama community. Residents note that their historical access is progressively declining.
- Observers discovered a line of T-bar posts that may presage construction of a fence (opposite Trout Stalker Ranch) making legal angler access to the 1990 easement more problematic.

NM Game Commission Certification of Non-Navigable Waters - Rio Dulce Ranch


- Segments within this section of river have been modified by in-channel dredging/ construction, to enhance trout production. Such activity requires a US Army Corps of Engineers Section 404 (dredge and fill) permit, which the owner evidently did not obtain.
- A fence, featuring multi-strand barbed wire topped by concertina wire, denies access making paddler ingress a deadly endeavor.
- Access is limited to commercial fly fishermen and is exclusively overland.
- The closure eliminates, or makes more problematic, access to National Forest land, downstream.
- Non-DGF signage was added, making plain that the intent of the barrier is to prevent passage by those navigating the river, effectively eliminating boating on the entire segment of the Pecos River that offers runnable Class IV rapids. The language of DGF signs, the statute and rule, refers to "operation of watercraft", leading landowners to believe that they are permitted to fence out paddlers.



NM Game Commission Certification of Non-Navigable Waters - Mimbres River






- This NNW application impacts paddler access to the Lobato Gorge, which is boatable during spring runoff (April—June) most years.
- Lobato Gorge is listed in paddler guidebooks as a desirable Class IV boating segment.

- Previous Ranch owners allowed seasonal river access/passage and even provided shuttle from Chama Bridge using their golf cart.
- Granting this application could unduly restrict public access to the northeast quadrant of Sargent State Wildlife Area.

- Archuleta Creek Campground and Rio Chama Trailhead on FR121/445 enables paddlers to access this beautiful class II/III stretch for several miles in Colorado, before abruptly coming to the Oso Pardo boundary fence, requiring portage, or trespass to forest road right-of-way.



NM Game Commission Certification of Non-Navigable Waters - River Bend Ranch

- According to its color prospectus River Bend Ranch " has the potential for the discriminate owner looking for a one-of-a-kind home and retreat or the investor/entrepreneur desiring a spectacular long-term potential development property".
- The prospectus makes plain that the dominant agenda of NNW certification is the privatization of New Mexico streams like the Pecos River, which are not only desirable locations for public recreation, but also possess monetary value as private resorts.
- To the degree that NNW Certification increases the value of these real estate properties, Game Commission's issuing of certificates can be seen as a grant of monetary value to private persons, which may be illegal under the anti-donation clause of the NM Constitution.
- The prospect of another exclosure fence on this property would further fragment the boatable water on the Pecos River between Cowles and Village of Pecos.

NM Game Commission Certification of Non-Navigable Waters - Canones Creek Ranch

- This segment of the Rio Chama is among those listed as boatable in NM State Parks 1983 publication "New Mexico Whitewater: A Guide to River Trips".
- Cross river fences are described as "frequent and dangerous", requiring boaters to portage across private land.
- River diversions on the Canones Creek Ranch have been constructed to maintain connectivity.
- AW considers such diversions to be "boater friendly", in contrast to the older weir-dam diversions which are notoriously hazardous.
- The segment is quite popular with New Mexico paddlers. AW has documented a number of boating excursions on this section of the Rio Chama
- Barriers on the Canones Creek Ranch section could eliminate access to a very popular Chama run.
