Land of Enchantment Legacy Fund Overview

2023 Regular Legislative Session

- SB 9 created the Land of Enchantment Legacy (Expendable) Fund and the Conservation Legacy Permanent Fund
- HB 2 invested \$50M in each fund (\$100M total)

2024 Regular Legislative Session

• HB 2 invested \$300M in the Conservation Legacy Permanent Fund

Forest and Watershed Restoration Act (FAWRA)

- Established in 2019 with \$2M/year
- With LOE, \$3.4M in F25-FY28
- Established the FAWRA Advisory Board to recommend projects for funding
- Since 2019:
 - \circ 25 projects recommended
 - \circ 13,506 acres restored
 - \circ \$4.6M FAWRA funds expended
 - \circ \$4.8M federal funds leveraged
- 14,300 shovel ready acres





Natural Heritage Conservation Act

Program Overview

- Before LOE Legacy, no consistent funding (\$1.4M in FY25)
- Projects are recommended by the Natural Lands Protection Committee
- Eligible applicants: governmental entities and nations, tribes, and pueblos
- Applicants may partner with nonprofit conservation organizations on applications
- Project types:
 - Agricultural Easements
 - Conservation Easements
 - Restoration Projects
- Two requests for applications have been completed (March and August 2024) and a third request for applications will open this fall





Natural Heritage Conservation Act – FY25 Funded Projects Y-T-D

Ranchos Las Lagunas Agricultural Easement (Santa Fe County)

- Santa Fe-Pojoaque Soil & Water Conservation District with Santa Fe Conservation Trust
- 100-acre farmland protection
- Irrigated w/acequia water rights, produces hay and beef
- Conservation values: agricultural, wildlife, scenic open space
- NHCA funding \$595,000





Natural Heritage Conservation Act – FY25 Funded Projects Y-T-D

Franklin-Coggins Conservation Easement (Mora County)

- EMNRD, Forestry Division with NM Land Conservancy
- 198.73-acre ponderosa pine-fir forest, Coyote Creek floodplain and agricultural pastures
- Conservation values: forestry, agricultural, water, wildlife habitat, scenic open space
- NHCA funding \$73,897





Natural Heritage Conservation Act – FY25 Funded Projects Y-T-D

Bear Canyon Conservation Easement (Sandoval County)

- 26.5-acre fir-spruce forest in the Jemez Mountains
- Conservation values: forestry, water, wildlife habitat, scenic open space
- NHCA funding \$56,278





Natural Heritage Conservation Act

FY25 Requests for Projects tiered off the existing rule created in 1995.

Lessons learned by using the Rule: FY25 LOE funds created an opportunity to test rule and identify improvements. Key findings are:

- Transaction costs have risen substantially since 1995 and the cap on transaction costs in the existing rule is too low.
- Existing rule requires baseline property assessment to be recorded with the deed and available to the public; this is a privacy risk to landowners and is no longer the standard required by the Land Trust Accreditation Board.
- Paper copies of applications are required in the existing rule and e-copies are not allowable.
- Amending the rule is an EMNRD priority for FY25 with the goal of issuing the FY26 RFP under the new rules.
