**RE: SUBCOMMITTEE REQUEST: ACTION ON SCHOOL TRANSPORTATION
LEGISLATION CONSIDERED BY THE 2013 LEGISLATURE**

INTRODUCTION

During the September 2013 meeting of the Legislative Education Study Committee (LESC) Interim Subcommittee on School Bus Transportation, the subcommittee requested that LESC staff produce a list of the six pieces of school transportation legislation endorsed by the LESC for the 2013 legislative session and final legislative action on those bills.

ACTION ON SELECTED LEGISLATION BY THE 2013 LEGISLATURE

- HB 328, *School Bus Fuel Gross Receipts*
