1. INTRODUCTION

The legislative council service (LCS) invites contractors (bidders) to submit bid proposals in accordance with the outlines and specifications contained in this request for bids (RFB). This RFB contains specific requests for information. In responding to this RFB, bidders are encouraged to provide any additional information they believe is relevant.

The purpose of this procurement is to select a contractor to supply and deliver food service products and supplies during legislative sessions.

2. SEQUENCE OF EVENTS

A. Release of RFB	November 24, 2010
B. Submission of bid proposals	December 8, 2010
C. Evaluation of bid proposals & selection	December 10, 2010

The selection date is subject to extension at the discretion of the LCS. The effective date of the contract is tentative; it is dependent on the selection date, the length of time required for contract negotiation and the length of time for processing the contract.

The events identified in the schedule above are briefly described below.

A. Release of RFB. This RFB will be advertised in two (2) newspapers of general circulation pursuant to Sections 13-1-104 and 13-1-113 NMSA 1978, and prospective bidders may direct questions about the RFB to Kathy Pacheco-Dofflemeyer at the office of the LCS, 411 State Capitol, Santa Fe, New Mexico, 87501; telephone (505) 986-4600.

B. Submission of Bid Proposals. Two (2) copies of the bid proposal and supporting documentation shall be submitted to the LCS. Bid proposals must be in the format specified in Paragraph 5 of this RFB and must be signed by the bidder.

The deadline for receipt of bid proposals by the LCS is December 8, 2010 no later than 4:00 p.m. Bid proposals will be time-stamped upon receipt.

All bid proposals shall be submitted in sealed envelopes marked "Bid Proposal for State House Food Service Products and Supplies".

SEALED BID PROPOSAL

A bid proposal may be modified by a bidder prior to the deadline for submission of bid proposals by delivery of a written modification to the above address. The sealed envelope shall be marked "Modification to Bid Proposal for State House Food Service Products and Supplies".

A bid proposal may be withdrawn prior to the deadline for submission of bid proposals by delivering written notice or by telephone notification to the person listed above.

Any bid proposal or modification received after the deadline for submission of bid proposals will be considered late. Unless a late bid proposal is the only one received, no late bid proposal or late modification will be considered unless it would have been timely but for the action or inaction of the LCS. Time limits will not otherwise be waived.

Bid proposals will be opened publicly at 4:00 p.m. on December 8, 2010 in Room 411 of the State Capitol.

C. Evaluation of Bid Proposals. Bid proposals will be evaluated by the LCS using the criteria listed in Paragraph 7 of this RFB. During the evaluation process, the LCS may seek clarification from bidders, but will **NOT** negotiate with bidders.

D. Selection of Bidder. The contractor selected to perform the work and those contractors not selected will be notified in writing by the LCS. Selection does **NOT** constitute an obligation to contract with the successful bidder.

3. AMENDMENTS TO RFB

If there are amendments to this RFB, they shall be in writing and shall be mailed to all individuals who received the RFB. Amendments shall be distributed with sufficient time to allow bidders to consider the amendments in preparing their bid proposals. If necessary, the deadline for submission of bid proposals will be extended by the amendment.

The written acknowledgment form mailed with the amendment shall be completed by the bidder and submitted with the bid proposal as evidence of receipt of the amendment.

4. CANCELLATION OF RFB — REJECTION OF BID PROPOSALS

The LCS reserves the right to cancel this RFB at any time and for any reason.

Any and all bid proposals may be rejected in whole or in part when it is in the interest of the LCS to do so. The LCS shall not be responsible for the payment of any costs incurred by the bidder in the preparation or submission of a bid proposal.

The issuance of this RFB, the receipt of bid proposals or the selection of a contractor in no manner obligates the LCS to the eventual purchase of goods or services. This process is solely at the discretion of the LCS and may be terminated without penalty or obligation at any time prior to the signing of a written contract.

5. BID PROPOSAL FORMAT

Bidders shall include the following information in their bid proposals.

A. Letter of Transmittal. Include the following information:

- (1) the name, address and telephone number of the bidder;

- (2) the signature of the bidder;
- (3) the date of the bid proposal;
- (4) a statement that the bidder, if awarded the contract, will comply with the contract terms and conditions set forth in this RFB; and
- (5) a statement that the bidder's bid proposal is valid for thirty (30) days after the deadline for submission of bid proposals.

B. Description and Price List of Food Products and Supplies. Provide a food product list along with a price list for the products and supplies, or their equivalent, listed in the scope of work in Paragraph 6 of this RFB.

C. Delivery Service. The bidder shall state the terms of delivery, including the available delivery schedules, notification time necessary for changes in orders and supplemental orders and related costs, if any.

D. Related Experience and Qualifications. The bidder shall include in the bid proposal prior experience and qualifications related to accomplishing the scope of work contained in Paragraph 6 of this RFB.

6. SCOPE OF WORK

The contractor shall be able to provide and deliver food products and supplies listed in Appendix A, or their equivalent, to the New Mexico state house food service department during the 2011 legislative session, beginning on January 10, 2011 and ending on March 19, 2011. Deliveries shall be daily. The contractor shall also be able to make deliveries as necessary when ordered by the food service manager. The contractor shall be able to supply the food products and supplies or their equivalent listed in Appendix A (see attached). The contractor shall also be able to provide products and supplies for special sessions of the legislature.

7. EVALUATION

A responsible bidder whose bid proposal is most advantageous to the LCS shall be selected to perform the services. A responsible bidder shall be able to supply food products and supplies of equal or better quality than that specified in Paragraph 6 of this RFB and deliver those products and supplies in accordance with the requirements of Paragraph 6. The following factors shall be evaluated:

- resident business or resident manufacturer certification;
- price of food products and supplies; and
- ability to deliver products and supplies in accordance with the needs of the New Mexico state house food service department.

8. CONTRACT TERMS AND CONDITIONS

The contract between the LCS and a successful bidder shall contain substantially the following terms and conditions. In the letter of transmittal, the bidder shall include a statement agreeing to these terms and conditions.

A. Scope of Work. This portion of the contract will be drafted following selection of an individual to perform the services. It will incorporate the scope of work in Paragraph 6 of this RFB and the description of products and services from the bidder's bid proposal.

B. Compensation. Compensation shall be as specified in the contract plus applicable New Mexico gross receipts taxes. The LCS shall pay the contractor the New Mexico gross receipts tax for which the contractor is liable on the amount of compensation paid under the contract.

C. Term. The contract shall be effective on the date the last of the parties to the contract signs the contract. The contract may be a multi-term contract and may contain provisions for renewal for periods cumulating not more than eight (8) years. The price agreement in the contract may be extended by mutual agreement of the contractor and the LCS director. Provisions of a renewal contract shall be the same as the original contract except for necessary changes in the term of the contract, legislative session dates contained in the scope of work and market price adjustments for food products and supplies.

D. Termination. The contract may be terminated by either of the parties upon written notice delivered to the other party at least thirty (30) days prior to the intended date of termination. A party may not nullify obligations or liabilities already incurred for performance or for failure to perform prior to the date of termination.

E. Status of Contractor. The contractor is an independent contractor performing services for the LCS and is not an employee of the state of New Mexico. The contractor shall not accrue leave, retirement, insurance, bonding, use of state vehicles or any other benefits afforded to employees of the state by virtue of the contract.

F. Assignment. The contractor shall not assign or transfer any interest in the contract or assign any claims for money due or to become due under the contract without the prior written approval of the LCS. An approved assignment or transfer shall include a provision that binds the assignee or transferee to all terms and conditions of this agreement.

G. Subcontracting. The contractor shall not subcontract any portion of the services to be performed under the contract without the prior written approval of the LCS.

H. Records and Audit. The contractor shall maintain detailed records that indicate the date, time and nature of services rendered. These records shall be subject to inspection by the LCS and the state auditor. The LCS shall have the right to audit billings both before and after payment. Payment under the contract shall not foreclose the right of the LCS to recover excessive or illegal payments.

I. Release. The contractor shall, upon final payment of the amount due under the contract, release the LCS, its employees and the state from all liabilities, claims and obligations arising from or under the contract.

J. Authority. The contractor agrees not to purport to bind the state to any obligation not

assumed in the contract by the state, unless the contractor has express written authority from the LCS to do so, and then only within the strict limits of that authority.

K. Conflict of Interest. The contractor shall warrant that the contractor has no interest and shall not acquire any interest, direct or indirect, that does or would conflict in any manner or degree with the performance of services required under the contract. The contractor shall further warrant that the contractor will not violate the provisions of Section 10-16-8 or 10-16-13 NMSA 1978 by entering into the contract.

L. Amendment. The contract shall not be altered, changed or amended except by an instrument in writing executed by the parties.

M. Merger. The contract shall incorporate all of the agreements, covenants and understandings between the parties thereto concerning the subject matter. No prior agreement or understanding, verbal or otherwise, of the parties shall be valid or enforceable unless embodied in the contract.

N. Applicable Law. The contract shall be governed by the laws of New Mexico.

O. Appropriation. The terms of the contract are contingent upon sufficient appropriations and authorization being made to the LCS by the New Mexico legislature. If sufficient appropriations and authorization are not made by the state legislature, the contract shall, notwithstanding the provisions of any other section of the contract, terminate immediately upon the contractor's receipt of written notice of termination from the LCS. The LCS's decision as to whether sufficient appropriations and authorization are made shall be accepted by the contractor and shall be final.

P. Notice. The Procurement Code, Sections 13-1-28 through 13-1-199 NMSA 1978, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, illegal gratuities and kickbacks.

Q. Equal Opportunity Compliance. The contractor shall agree to comply with all federal and state laws pertaining to equal employment opportunity. In accordance with all such laws, the contractor shall agree to ensure that no person in the United States shall, on the grounds of race, color, national origin, sex, sexual preference, age or handicap, be excluded from employment with or participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity performed under the contract. If the contractor is found to be not in compliance with these requirements during the life of the contract, the contractor shall agree to take appropriate steps to correct these deficiencies.

R. Indemnity. The contractor shall hold harmless and indemnify the state of New Mexico against any injury, loss or damage, including cost of defense, arising out of the negligent acts, errors or omissions of the contractor.
