

# MINUTES of the FOUR-HUNDRED-THIRTEENTH MEETING of the LEGISLATIVE COUNCIL

## **Approval of Minutes**

On a motion made, seconded and approved, the council adopted the minutes of the June 26, 2023 and July 28, 2023 meetings of the council as submitted.

# **Pre-Session Approval**

Mr. Burciaga explained that council approval is required for the chief clerks to hire presession staff.

On a motion made, seconded and passed, the council authorized the house and senate chief clerks to hire core pre-session staff beginning in October.

### **Interim Committee Business**

Mr. Burciaga explained that the Courts, Corrections and Justice Committee had requested funding for expert testimony, not to exceed \$5,000, regarding a presentation on artificial intelligence from the Criminal Justice Institute.

On a motion made, seconded and passed, the council authorized funding, not to exceed \$5,000, for expert testimony for the Courts, Corrections and Justice Committee.

Mr. Burciaga noted that two interim committees had rescheduled meetings due to funeral services for former Governor Bill Richardson. The Legislative Education Study Committee moved its meeting to September 20-22, and the Indian Affairs Committee moved its meeting to September 25-26.

## **Appointments**

Mr. Burciaga announced that Anjali Taneja was appointed by the speaker to the Insurance Nominating Committee and Nora Vasquez was reappointed to the committee, both for terms expiring on June 30, 2027.

### Status of Legislative District/Regional Staff Offices Study

Mr. Burciaga explained that surveys had been sent by Research & Polling, Inc. to legislators and legislative staff. He also noted that Architectural Research Consultants, Inc. were conducting a survey of office space around the state, the National Conference of State

Legislatures was assisting with research regarding legislative staff structures and support and The Focus Group was in communication with at least six other states to gather information.

Mr. Burciaga suggested a council meeting on October 16 for a presentation by the various groups working on the study.

## **Staff Reports**

Mr. Burciaga noted that audiovisual upgrades to committee rooms were still in progress. He said that work on the video boards in each chamber would be completed later in the month.

Mr. Burciaga indicated that he was continuing to develop policies for use of committee rooms and chambers by state agencies, nonprofit organizations and other nonlegislative entities. He noted that the legislature helped a number of organizations during the COVID-19 pandemic with meeting space, webcasting, archiving and closed captioning. However, those are costs that cannot be recouped and even if they could they would be paid into the General Fund, not into legislative funds. He stated that there will be some limitations on what can be provided for nonlegislative entities.

Mr. Burciaga said that long-time legislative employees David Pacheco and Kathy Pacheco-Dofflemeyer lost their mother recently.

Mr. Burciaga also announced funeral services and associated events for former Governor Bill Richardson.

#### **Other Business**

Regarding a recent public health order that was challenged, a member inquired about procedures for initiating an extraordinary session, and Senator Stewart clarified that the process would be initiated by legislators rather than the Legislative Council. A member also inquired about Article 4, Section 35 of the Constitution of New Mexico impeachment procedures, and Senator Stewart advised that the member consult Mr. Burciaga.

### Adjournment

There being no further business before the council, the meeting adjourned at 2:11 p.m.
