# COVID-19: Statewide Responses and Administration of Services (9:16 a.m.)

Scrase, secretary, Human Services Department (HSD); Alex Castillo Smith, manager, Strategic Planning and Special Projects, Office of the Secretary, HSD; Kathyleen Kunkel, secretary, Department of Health (DOH); Dr. Chad Smelser, deputy state epidemiologist, DOH; James C. Kenney, secretary, Department of Environment; and Brian Blalock, secretary, Children, Youth and Families Department (CYFD), provided the committee with presentations on COVID-19 relief measures implemented by their respective agencies. Comments from committee members included the following:

- contact tracing should be tied to state agencies and subject matter experts;
- an inquiry about testing supply shortages;
- whether face shields should be used in addition to face masks;
- fear that immigration status would prevent the public from being tested for COVID-19;
- the likelihood of rationing care in treating COVID-19;
- the DOH should intervene when businesses fail to comply with mandatory health orders;
- in smaller communities across the state, residents are still gathering in groups and not practicing social distancing;
- dissemination of misinformation needs to be addressed;
- New Mexicans are receiving bills for testing, but they should not;

- it is important for public health administration offices to prepare for the availability of a COVID-19 vaccine; and
- increasing state COVID-19 relief efforts in rural New Mexico communities, specifically Native American pueblos.

# Public Comment (12:35 p.m.)

Comments from members of the public included concerns about the following:

- health care workforce development;
- access to health care in rural communities and rural practitioner residency;
- access to timely data;
- addiction and mental health services;
- expanding the role of primary care practitioners;
- the experiences of people of color with respect to COVID-19; and
- legalizing recreational cannabis and access to medical cannabis in schools.

# HSD Program and Service Delivery: Opportunities to Improve Performance During COVID-19 (1:34 p.m.)

Comments from committee members regarding topics that they would like included in the work plan included the following:

- the Vocational Rehabilitation Division of the Public Education Department should be included in the late September meeting date topic addressing professional licensure;
- a COVID-19 vaccine should be included in the topic of prescription drug costs;
- oversight of boarding homes;
- dentistry for patients with special needs at the University of New Mexico;
- sex education and affirmative consent instruction for seventh graders;

- the impact of COVID-19 on essential workers, especially Latinos, through organizations such as New Mexico Voices for Children, Organizers in the Land of Enchantment, El Centro Family Health, SOMOS and NM CAFé;
- the Long-Acting Reversible Contraception Mentorship Program in the context of COVID-19;
- the Cerebral Palsy Task Force;
- the Crown Act;
- reporting required by legislation that was not heard during the last interim;
- midwives and the utility of midwife practices in rural areas;
- rehabilitation from COVID-19;
- streamlining and simplifying the licensing process for behavioral health professionals, including reciprocity agreements with other states;
- amending statutes to create penalties for state employees who disclose patient information;
- human trafficking;
- the Physical Therapy Act and the national compact;
- report from the New Mexico Nurses Association about the implementation of the Safe Harbor for Nurses Act;
- revisions to the Patient Protection Act;
- funding for the New Mexico Poison and Drug Information Center and Office of the Medical Investigator; and
- reporting required by statute regarding access to dental care; the health care workforce working group; and the DOH's Harm Reduction Program.
