## Welcome and Introductions (9:09 a.m.)

Representative Garcia welcomed everyone to the meeting. Members of the committee and staff introduced themselves.

## New Mexico Veterans Affairs Health Care System (9:13 a.m.)

Larry Campos, congressional liaison, New Mexico Veterans Affairs Health Care System, gave a presentation about the impact that the Hermits Peak/Calf Canyon, Cerro Pelado and Black Fire wildfires had on the community-based outpatient clinics. ## Healing America's Heroes (9:41 a.m.)

Eddie Crain, founder, Healing America's Heroes, introduced former Representative Bob Wooley, District 66. Mr. Crain said that there has been an initial conversation about leasing the Fort Stanton prison facility and converting it to a veterans outreach center. # Veterans and Military Family Caucus (10:56 a.m.)

Claudia Risner, chair, Veterans and Military Families Caucus, said that the caucus has been established for nine years. The primary mission of the caucus is advocacy for military families and active duty service members. She said that the caucus also advocates for members to run for office. One important issue that is ongoing is a landscape assessment done by the AmericaServes program in partnership with Syracuse University. # NMMI (12:02 p.m.)

Colonel David W. West, chief of staff, NMMI, welcomed committee members to the NMMI. Colonel West said that the NMMI will be coming to the legislature to extend the General Richard T. Knowles Legislative Scholarship Program from four years to six years. He said that there will be 200 students on the scholarship.

# Veterans Benefits Administration (12:26 p.m.)

Corliss De La Garza, veteran readiness and employment officer, Albuquerque Regional Office, Veterans Benefits Administration, United States Department of Veterans Affairs, said that

the administration is an employment program but does provide an educational program, and there are requirements that must be met in order to be a part of the program. Currently, there are 400 veterans who are enrolled in four-year institutions. The presentation can be found here:

#### Southwest New Mexico Veteran's Transportation Network (1:38 p.m.)

Magil Duran, Sr., president, Southeast New Mexico Veteran's Transportation Network, said that the network started in 2008. Mr. Duran said that the network is a 501(c)3 nonprofit that does not receive and will not accept any money from the federal government. Instead, the network makes money to cover the cost of travel expenses, vehicle maintenance and other needs through fundraisers, private donations and grants from foundations.

## New Mexico National Guard Youth ChalleNGe Academy (2:28 p.m.)

Tina Cisneros, program director, New Mexico National Guard Youth ChalleNGe Academy, introduced Maribel Bugarim, parent, and Raymond Peña, deputy commandant, New Mexico National Guard Youth ChalleNGe Academy. Ms. Cisneros said that the academy program provides education leadership, character development and life coping skills to New Mexico high school dropouts so that they become productive citizens. Mr. Peña said that the program has been beneficial to him and that he has gained attributable life skills.
