SUMMARY

Synopsis of Bill

HB421 appropriates \$100.0 from the general fund to OSE for expenditure in FY2001 to establish and administer a state water banking program. Any unexpended or unencumbered balances remaining at the end of FY2001 shall revert to the general fund.

Significant Issues

While both NMDA and OSE listed the appropriation as non-recurring, the bill establishes recurring costs in the form of a water bank director to administer the program. Additionally, the state engineer contends the \$100.0 amount is insufficient to establish and administer a state water bank program pursuant to HB420 and SB323.

FISCAL/ADMINISTRATIVE IMPLICATIONS

According to OSE, a significant portion of the appropriation would go towards the hiring of a full-time water bank director in accordance with HB420 and SB323, which provides for state regional water banks. Remaining funds, if any, would be used to conduct hearings and adopt rules for administration of state regional water banks. If the substantive legislation providing for state regional water banks does not become law, these funds would remain unspent and revert to the general fund at the end of FY2001.

CONFLICT/DUPLICATION/COMPANIONSHIP/RELATIONSHIP

HB421 would support the functions proposed by HB420 and SB323 relating to state regional water banks. However, the language used in this bill to describe the water banking program is not identical to the language

in the two corresponding bills. One alternative offered by OSE is to replace language in HB420 and SB323 that pertain to "state regional water banks and appointing a full-time water bank director" and insert "for a state water banking program."

Without this legislation, no specific funding will be available to fund the appointment of a full-time water bank director or otherwise fund the establishment and administration of state regional water banks if the two substantive bills become law.
