15 between public and private entities be commended for working
16 together to provide an improved quality of life for citizens of
17 Roswell and Chaves county, New Mexico: eastern New Mexico
18 university at Roswell; Trailnet, Retirement Inn, OIC computer
19 services and Chaves county retired and senior volunteer
20 program; and

21 BE IT FURTHER RESOLVED that copies of this memorial be
22 transmitted to the president and to board of regent members of
23 eastern New Mexico University at Roswell and to the directors
24 of Trailnet, Retirement Inn, OIC computer services and Chaves
