3. On page 2, lines 1 and 2, strike "thirty-six and forty-seven hundredths" and insert in lieu thereof "thirty-seven and forty-two hundredths".

4. On page 2, lines 24 and 25, strike the underscored money amount and insert in lieu thereof "six million four hundred fifty thousand dollars (\$6,450,000)".

5. On page 2, line 25 and page 3, line 1, strike the underscored money amount and insert in lieu thereof "five million eight hundred fifty thousand dollars (\$5,850,000)".

6. On page 3, lines 10 and 11, strike the money amount and insert in lieu thereof "Three million one hundred fifty thousand dollars (\$3,150,000)".

7. On page 4, line 7, strike "and".

8. On page 4, line 11, strike the period and insert in lieu thereof "; and".

9. On page 4, between lines 11 and 12, insert a new paragraph to read:

"(6) three hundred fifty thousand dollars (\$350,000) to class B counties with a population of more than fifty thousand but less than fifty-five thousand according to

the most recent federal decennial census.".

10. On page 6, lines 17 and 18, strike the underscored money amount and insert in lieu thereof "six million four hundred fifty thousand dollars (\$6,450,000)".

11. On page 6, lines 18 and 19, strike the underscored money amount and insert in lieu thereof "five million eight hundred fifty thousand dollars (\$5,850,000)".,
