AN ACT

RELATING TO BOARDS; EXTENDING THE SUNSET DATES FOR CERTAIN
BOARDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 61-2-18 NMSA 1978 (being Laws 1979,
Chapter 12, Section 3, as amended) is amended to read:

"61-2-18. TERMINATION OF AGENCY LIFE--DELAYED REPEAL. --
The board of optometry is terminated on July 1, [2003] 2009
pursuant to the Sunset Act. The board shall continue to
operate according to the provisions of [~~Chapter 61, Article 2~~
~~NMSA 1978~~] the Optometry Act until July 1, [2004] 2010.
Effective July 1, [~~2004, Chapter 61, Article 2 NMSA 1978~~] 2010,
the Optometry Act is repealed."
