Amendment sponsored by Senator Ben D. Altamirano

1. On page 2, line 5, strike "Weekly" and insert in lieu thereof "Effective July 1, 2003, weekly".

2. On page 5, line 8, strike "An" and insert in lieu thereof "Effective January 1, 2004, an".

3. On page 6, line 3, strike "Dependency" and insert in lieu thereof "Effective January 1, 2004, dependency".

4. On page 7, line 1, after "amount" insert "pursuant to Subsections C and D of this section".

5. On page 18, line 9, after "(b)" insert "effective July 1, 2003, ".

6. On page 34, strike lines 21 through 25 and on page 35, strike lines 1 through 10 and insert in lieu thereof:
