AN ACT

RELATING TO THE REDISTRICTING OF THE CONGRESSIONAL DISTRICTS;  
ESTABLISHING CONGRESSIONAL DISTRICTS FOR THE ELECTION OF  
REPRESENTATIVES TO THE UNITED STATES CONGRESS; AMENDING,  
REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 1-15-16 NMSA 1978 (being Laws 1991  
(1st S.S.), Chapter 7, Section 1) is repealed and a new Section  
1-15-16 NMSA 1978 is enacted to read:

"1-15-16. [NEW MATERIAL] UNITED STATES REPRESENTATIVE--  
COMPOSITION OF DISTRICTS. --

A. Congressional district one is composed of

21 precincts 1 through 3 and 5; Roosevelt county; Sierra county;  
22 Socorro county precincts 1 through 14, 16 and 17; Torrance  
23 county precincts 9 and 10; and Valencia county precincts 7, 17,  
24 20, 27, 29 through 31, 33 and 34.

25 C. Congressional district three is composed of

15 Section 2. Section 1-15-16.1 NMSA 1978 (being Laws 1991  
 16 (1st S.S.), Chapter 7, Section 2) is amended to read:

17 "1-15-16.1. PRECINCTS. --

18 A. Precinct designations and boundaries used in the  
 19 [~~1991~~] 2003 congressional redistricting are those precinct  
 20 designations and boundaries established pursuant to the  
 21 Precinct Boundary Adjustment Act and revised and approved  
 22 pursuant to that act by the secretary of state as of [~~August~~  
 23 ~~16, 1991~~] January 1, 2003.

24 B. [~~The boards~~] A board of county commissioners  
 25 shall not create any precinct that lies in more than one

1 congressional district [~~nor~~] and shall [~~the boards of county~~  
2 ~~commissioners~~] not divide any precinct so that the divided  
3 parts of the precinct are situated in two or more congressional  
4 districts. Votes cast in [~~any general, primary or other~~] a  
5 statewide election from precincts created or divided in  
6 violation of this subsection shall be invalid and shall not be  
7 counted or canvassed. "
