## SUMMARY

## Synopsis of Bill

House Bill 464 adds a new section to the Motor Vehicle Code to direct TRD to issue a special design license plate for retired NM state police officers. The special license plate would be issued for a one-time fee of $\$ 25$ in addition to the regular motor vehicle registration fees.

The TRD secretary will approve the final plate design for retired NM state police officers in accordance with New Mexico law.

## Significant Issues

1. Section A of the bill also requires the person wanting the special license plate must submit proof to TRD that he is a retired state police officer. Such proof shall include the submission of a retirement commission from the New Mexico State Police.
2. According to Section B and C, a person who misrepresents himself as a retired state police officer is guilty of a petty misdemeanor and shall be sentenced pursuant to Section 31-19-1 NMSA 1978.
3. Of the $\$ 25$ fee, $\$ 10$ is to be appropriated and retained by the Motor Vehicle Division (MVD) to cover the costs of manufacturing and issuing the license plates. The remaining $\$ 15$ would be deposited with the State Treasurer for credit to the Motor Vehicle Suspense Fund for distribution in accordance with Section 66-6-23 NMSA 1978 (see Revenue table on page 1).

## FISCAL IMPLICATIONS

The portion of the fee that MVD receives (\$10) would cover the cost of the license plate in the out years, but the initial costs for production would need to be absorbed by the division.

The U.S. Census Bureau's 2000 Statistical Abstract of the United States reports approximately 435 State Police Officers in New Mexico in 1996. New Mexico Public Employees Retirement Association (PERA) staff estimated between 400 and 450 retired State Police Officers. The fiscal impact during the first year would probably involve the sale of fewer than 500 plates. This would provide less than $\$ 5,000$ in revenue to the Motor Vehicle Division, which probably would not cover the cost of production. The impact on the State Road Fund would be less than $\$ 4,000$, and the impact on local government funds would be minimal.

After the first year, the recurring demand and revenue generated from these license plates would probably involve fewer than 100 plates per year (less than $\$ 1,000$ ).

It is unclear whether demand would outweigh the costs of manufacturing the retired state police officer license plates given the number of state police retiring each year.
