**A JOINT MEMORIAL**

REQUESTING THE UNITED STATES SENATORS REPRESENTING NEW MEXICO  
TO SUPPORT A SENATE FLOOR VOTE ON THE NOMINATION OF MIGUEL  
ESTRADA TO THE UNITED STATES COURT OF APPEALS.

**WHEREAS, on May 9, 2001, President George W. Bush  
nominated Miguel A. Estrada to fill a vacancy on the United  
States court of appeals for the District of Columbia circuit;  
and**

**WHEREAS, Mr. Estrada's credentials are uncontested,  
beginning with his mastery of the English language and American  
culture upon his arrival in the United States as an immigrant  
from Honduras and his graduation magna cum laude from Columbia  
university and Harvard law school; and**

**WHEREAS, Mr. Estrada has received support from liberal and  
conservative colleagues alike who attest that he is one of the**

1 most brilliant and effective appellate lawyers in the nation;

3 WHEREAS, organizations that support Mr. Estrada include  
4 the league of united Latin American citizens; the United States  
5 chamber of commerce; the Hispanic national bar association; the  
6 Hispanic business roundtable and the Latino coalition; and

7 WHEREAS, Mr. Estrada would be the first Hispanic to sit on  
8 the United States court of appeals for the District of Columbia  
9 circuit, an important and prestigious position within the  
10 federal courts of appeals; and

11 WHEREAS, over one and one-half years have passed since Mr.  
12 Estrada's nomination without a vote on the United States senate  
13 floor; and

14 WHEREAS, the United States senate judiciary committee has  
15 issued a favorable report to the senate but because of partisan  
16 politics democratic senators threaten to filibuster a senate  
17 floor vote;

18 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
19 STATE OF NEW MEXICO that the Honorable Pete Domenici and the  
20 Honorable Jeff Bingaman be requested to work to allow a vote on  
21 the floor of the United States senate on the appointment of  
22 Miguel Estrada to the United States court of appeals for the  
23 District of Columbia Circuit; and

24 BE IT FURTHER RESOLVED that copies of this memorial be
