10 A JOINT RESOLUTION

11 PROPOSING AMENDMENTS TO ARTICLE 12 OF THE CONSTITUTION OF NEW
12 MEXICO TO MAKE CHANGES IN THE SELECTION PROCESS FOR BOARDS OF
13 REGENTS.

15 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 Section 1. It is proposed to amend Article 12, Section 13
17 of the constitution of New Mexico to read:

18 "The legislature shall provide for the control and
19 management of each of said institutions [~~except the university~~
20 ~~of New Mexico~~] by a board of regents for each institution,
21 consisting of [~~five~~] seven members, four of whom shall be
22 qualified electors of the state of New Mexico, one of whom
23 shall be a member of the student body of the institution, one
24 of whom shall be a full-time, tenured member of the faculty of
25 the institution and no more than [~~three~~] four of whom at the

1 time of their appointment shall be members of the same
2 political party; provided, however, that the student body and
3 faculty member provision in this section shall not apply to the
4 New Mexico school for the deaf, the New Mexico military
5 institute, the northern New Mexico state school or the New
6 Mexico school for the visually handicapped, and for each of
7 those four institutions [~~all five members of~~] the board of
8 regents shall consist of five members, all of whom shall be
9 qualified electors of the state of New Mexico. The governor
10 shall nominate and by and with the consent of the senate shall
11 appoint the members of each board of regents for each of said
12 institutions. The terms of said nonstudent and nonfaculty
13 members shall be for six years, provided that of the five first
14 appointed the terms of two shall be for two years, the terms
15 for two shall be for four years, and the term of one shall be
16 for six years. Following the approval by the voters of this
17 amendment and upon the first vacancy of a position held by a
18 nonstudent member on each eligible institution's board of
19 regents, the governor shall nominate and by and with the
20 consent of the senate shall appoint a student and a faculty
21 member to each serve a two-year term. The governor shall
22 select, with the advice and consent of the senate, a student
23 and a faculty member from [~~a list~~] lists provided by the
24 president of the institution. [~~In making the list~~] The
25 president of the institution shall [~~give due consideration to~~

2 the student body [~~presidents~~] and faculty senate president of
3 the institution.
