AN ACT

RELATING TO GAME AND FISH; RAISING CERTAIN NONRESIDENT AND  
TEMPORARY LICENSE FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 17-3-13 NMSA 1978 (being Laws 1964  
(1st S.S.), Chapter 17, Section 5, as amended) is amended to  
read:

"17-3-13. LICENSE FEES. --

A. The director of the department of game and fish  
shall keep a record of all money received and licenses and  
permits issued by him, numbering each class separately. Upon  
satisfactory proof that a license or permit has been lost  
before its expiration, he may issue a duplicate and collect a  
just and reasonable fee for it as determined by regulation of  
the state game commission.

1                    B. The director of the department of game and fish  
 2 shall collect the following fees for each license of the class  
 3 indicated:
