10 A JOINT MEMORIAL

11 REQUESTING THAT THE ENLACE IN NEW MEXICO PROGRAM BE INCLUDED IN  
12 THE MEMBERSHIP OF COMMUNITY INPUT BODIES ESTABLISHED BY THE  
13 PUBLIC EDUCATION DEPARTMENT.

15 WHEREAS, New Mexico's Latino students and communities  
16 contribute to the multicultural heritage of the state,  
17 representing significant promise for the economic future of the  
18 state with improved educational attainment; and

19 WHEREAS, data from the public education department, the  
20 commission on higher education and the national center for  
21 education statistics illustrate a significant achievement gap  
22 between Latino students and other student groups in New Mexico  
23 public schools; and

24 WHEREAS, this achievement gap results in considerable  
25 economic and social costs to New Mexico as a result of the high

1 Latino student dropout rates and low graduation rates that  
2 limit opportunities for future educational participation and  
3 economic success; and

4 WHEREAS, ENLACE in New Mexico, engaging Latino communities  
5 for education, was established with the assistance of a grant  
6 awarded by the W. K. Kellogg foundation as part of a national  
7 initiative to improve the educational participation and  
8 graduation rates of Latino students through enhanced community  
9 involvement; and

10 WHEREAS, ENLACE in New Mexico has created a framework for  
11 success that outlines effective educational methods in classes,  
12 schools and communities where Latino students are succeeding in  
13 their educational endeavors and increasing educational success;  
14 and

15 WHEREAS, state law requires the public education  
16 department to collaborate with the commission on higher  
17 education in aligning high school curricula and end-of-course  
18 tests with the placement tests administered by two- and four-  
19 year public institutions of higher education in New Mexico; and

20 WHEREAS, the public education department seeks to close  
21 the achievement gap through a variety of strategies, programs  
22 and activities, many of which include the establishment of  
23 community input entities such as local and statewide task  
24 forces, councils and advisory bodies;

25 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE

14 legislative education study committee for appropriate  
15 distribution.
