AN ACT

RELATING TO PUBLIC FINANCE; REMOVING INVESTMENT LIMITATIONS AND ESTABLISHING STANDARDS FOR PRUDENT INVESTMENT OF THE LAND GRANT PERMANENT FUNDS, THE SEVERANCE TAX PERMANENT FUND, THE EDUCATIONAL RETIREMENT FUND AND OF FUNDS ADMINISTERED PURSUANT TO THE PUBLIC EMPLOYEES RETIREMENT ACT; AMENDING AND REPEALING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 6-8-7 NMSA 1978 (being Laws 1957, Chapter 179, Section 7, as amended) is amended to read:

"6-8-7. POWERS AND DUTIES OF STATE INVESTMENT OFFICER-- INVESTMENT POLICY--INVESTMENT MANAGERS.--

A. Subject to the limitations, conditions and restrictions contained in policy-making regulations or resolutions adopted by the council and subject to prior

1 authorization by the council, the state investment officer may

25 should govern the activities of the investment office.

8 may hire one or more investment management firms to advise the
9 council with respect to the council's overall investment plan
10 for the investment of all funds managed by the investment
11 office and pay reasonable compensation for such advisory

13 budgeting and appropriation by the legislature. The terms of
14 any such investment management services contract shall
15 incorporate the statutory requirements for investment of funds

8 agreement with the council and that state agency pays at least
9 the direct cost of such services. Notwithstanding any
10 statutory provision governing state agency investments, the
11 state investment officer may invest funds available from a
12 state agency pursuant to a joint powers agreement in any type
13 of investment permitted for the land grant permanent funds
14 under the prudent investor rule. In performing investment
15 services for a state agency, the council and the state
16 investment officer are exempt from the New Mexico Securities
17 Act of 1986. As used in this subsection, "state agency" means
18 any branch, agency, department, board, instrumentality,
19 institution or political subdivision of the state, the New
20 Mexico finance authority and any tax-exempt private endowment
21 entity whose sole beneficiary is a state agency.

22 F. The state investment officer shall provide
23 quarterly performance reports to the legislative finance
24 committee. Annually, the state investment officer shall ratify
25 and provide written investment policies, including any

2 Section 2. Section 6-8-20 NMSA 1978 (being Laws 1987,
3 Chapter 219, Section 3, as amended) is amended to read:

4 "6-8-20. PRIVATE EQUITY INVESTMENT ADVISORY COMMITTEE
5 CREATED- - MEMBERSHIP- - DUTIES- - TERMS- - LIABILITIES- - CONFLICT OF
6 INTEREST. - -

7 A. There is created the "private equity investment
8 advisory committee" to the council. The committee consists of
9 the state investment officer, a member of the council appointed
10 by the governor and three members who are qualified by
11 competence and experience in finance and investment and
12 knowledgeable about the private equity investment process and
13 who are appointed by the governor.

14 B. Members appointed by the governor, except the
15 council member, shall be appointed for three-year terms;
16 provided that the terms of the initial committee members shall
17 be staggered so that the term of one member expires each year.
18 After the initial appointments, all governor-appointed members
19 shall be appointed for three-year terms. Members shall serve
20 until their successors are appointed. A vacancy occurring
21 other than by expiration of term shall be filled in the same
22 manner as the original appointment, but only for the unexpired
23 term.

15 necessary. The committee shall meet upon the call of the
16 chairman or the state investment officer.

19 all immunity and indemnification provided under that act.
