A MEMORIAL

REQUESTING THE CONGRESSIONAL DELEGATION OF THE STATE OF NEW MEXICO AND THE SECRETARY OF THE INTERIOR TO WORK TOWARD IMPROVING LAWS AND REGULATIONS PROTECTING SURFACE VALUES IN ENERGY DEVELOPMENT.

WHEREAS, the mineral and energy production and transmission industries provide substantial revenue to, as well as jobs and economic development in, New Mexico and the United States; and

WHEREAS, the continued responsible development of our nation's natural resources, with a commitment to environmental and property rights protection, is necessary to meet the nation's energy needs; and

WHEREAS, exploration for and development, production and transmission of mineral and energy resources can result in

1 damage, lost value and loss of uses of other real property and
2 surface resources; and

3 WHEREAS, it is necessary to protect the public welfare,
4 which is also dependent on these other values and resources,
5 and it is necessary to protect the economic well-being of the
6 owners and users of such real property and surface resources;
7 and

8 WHEREAS, an executive order of August 26, 2004 instructs
9 federal agencies to take "appropriate account of and respect
10 the interests of persons with ownership or other legally
11 recognized interests in land and other natural resources" in
12 their implementation of laws relating to natural resources; and

13 WHEREAS, owners of surface resources should be fully
14 compensated for injury to their persons or damage to and loss
15 of use and loss of value to their property resulting from
16 mineral and energy exploration, development, production and
17 transmission;

18 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
19 REPRESENTATIVES OF THE STATE OF NEW MEXICO that New Mexico's
20 congressional delegation and the United States secretary of the
21 interior be requested to support legal and administrative
22 reform to protect the rights of surface owners and decrease the
23 surface damage done during energy development; and

24 BE IT FURTHER RESOLVED that copies of this memorial be
25 transmitted to the members of New Mexico's congressional
