### SUMMARY

#### Synopsis of Bill

Senate Bill 361 appropriates \$500,000 from the General Fund to the State Commission of Public Records (SCPR) for expenditure in FY 2007 for the Office of the New Mexico State Historian's New Mexico history web site to enhance content development for the existing site.

### FISCAL IMPLICATIONS

The appropriation of contained in this bill is a recurring expense to the General Fund. Content development should be an on-going activity.

Any unexpended or unencumbered balance remaining at the end of FY 2007 shall revert to the General Fund.

The bill would provide continuing funding for content development for the NM history website. The agency currently has a \$38.0 special appropriation for content development and enhancement of the website, which builds on the design work done with previous appropriations. Without an additional special appropriation, content development would be slowed considerably since it would fall to the two existing staff of the Office of the State Historian. Given their other responsibilities, the time they would have to devote to content development would inevitably be limited.
