WHEREAS, rural and colonias communities are sorely lacking in infrastructure, accessibility, opportunities and sanitation services, and by working together, the state and individual counties could lift these communities up and provide better futures for the children in the communities who will in turn raise their own families on family properties, thereby making meaningful progress toward enhancing the most basic of human needs in these challenged communities; and

WHEREAS, residents of rural and colonias communities statewide face harsh challenges on a daily basis, but they are proud people who are reluctant to ask for help; and

WHEREAS, individual counties continue to undertake independent and ambitious infrastructure improvement plans designed to enhance social and economic development opportunities for all residents of New Mexico; and

WHEREAS, by initiating a statewide improvement program for rural and colonias communities, the state could partner with the thirty-three counties to empower these small communities and dramatically improve the quality of life in them, while simultaneously creating new entrepreneurial zones that will complement existing projects in incorporated municipalities;
