16. On page 9, line 7, after "plan", strike the remainder of the line, and on line 8, strike "year".

18. On page 9, line 11, strike "coordinate" and insert in lieu thereof "coordinating".

19. On page 9, line 14, after "M.", insert "as funding is available,".

45. On page 41, lines 21 through 23, strike Paragraph (8) in its entirety.

46. On page 41, line 24, after "remaining", insert "of the appropriations in Subsection A of this section".

47. On page 42, between lines 3 and 4, insert the following new subsection:

"C. Three hundred fifty thousand dollars (\$350,000) is appropriated from the general fund to the department of health for expenditure by the office of American Indian health in fiscal year 2009 and subsequent fiscal years for implementation of the American Indian Health Care Improvement Act. Any unexpended or unencumbered balance remaining at the end of a fiscal year shall not revert to the general fund."
