A MEMORIAL

REQUESTING THE ECONOMIC DEVELOPMENT DEPARTMENT AND THE TAXATION AND REVENUE DEPARTMENT TO EXAMINE THE EFFECTIVENESS OF CURRENT INCENTIVES TO PROMOTE AND SUSTAIN MANUFACTURING.

WHEREAS, manufacturing is a significant source of employment and economic benefit in the state; and

WHEREAS, retaining and encouraging growth in existing manufacturing operations is as important to the state's economy as attracting new manufacturers; and

WHEREAS, there is intense competition among states and nations for manufacturers because of the number of jobs manufacturers provide and the relatively high salaries that are paid to workers in those jobs; and

WHEREAS, the state of New Mexico has historically proven to be very successful in attracting new manufacturing

4 WHEREAS, other states and nations have become very
5 aggressive in providing tax and other incentives to attract
6 manufacturing operations; and

7 WHEREAS, New Mexico cannot afford to become complacent in
8 reviewing and revising tax and other business incentives as it
9 seeks to retain manufacturers in and recruit manufacturers to
10 New Mexico;

11 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
12 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the economic
13 development department and the taxation and revenue department
14 be requested to examine the effectiveness of current tax
15 incentives and other incentives to attract and retain
16 manufacturing operations to the state; and

17 BE IT FURTHER RESOLVED that, in conducting this
18 examination, these departments be requested to consult with
19 representatives of current manufacturing operations in the
20 state, members of the general business community, tax policy
21 experts, economists and local government officials; and

22 BE IT FURTHER RESOLVED that these departments be requested
23 to report the results of their examination and their
24 recommendations for any new legislation to the legislative
25 finance committee and the interim revenue stabilization and tax
