## SENATE EXECUTIVE MESSAGE NO. 100

The Honorable Timothy Z. Jennings, President Pro Tempore and Members of the New Mexico State Senate State Capitol Building Santa Fe, New Mexico 87501

Dear President Pro Tempore Jennings and Members of the Senate:

Today I am signing Senate Bill 182 which will provide \$141 million in General Fund for the FY10 budget and the general fund reserves by voiding stalled capital projects. These funds are essential for maintaining critical services for the most vulnerable New Mexicans. These funds are also crucial for sound fiscal management and for the ability of the state to respond to revenue fluctuations during these unstable economic times.

I believe it is necessary and fiscally prudent to sign this legislation. The bill will de-authorize appropriations for more than 2,500 capital outlay projects that have lingered on the books for too long. Many of these appropriations are more than four years old or have unspent balances. Although these de-authorized projects may otherwise have merit, it is our duty to ensure that taxpayer money is used efficiently and effectively and we cannot continue to carry forward these appropriations for projects that are not creating jobs, are not providing critical infrastructure and are tying up scarce financial resources.

I have vetoed all of Section 21 of the bill which would have established an exemption process for appropriations that meet certain criteria because it is ambiguous and redundant. Adequate review of project status was completed as a result of legislation from the 2009 Special Session (Laws 2009, Chapter 5, 1<sup>st</sup> SS; HB 17); the implementation of the "capital freeze" process; and the thorough review of project status by the Legislature, through its staff and its committees. Additionally, other provisions in Senate Bill 182 are sufficient to ensure all valid expenditures are reimbursed and valid binding written commitments are honored.

I have also taken steps through line item veto authority to protect projects that have recently secured federal or state matching funds, projects that are fully funded and shovel-ready, and projects that have demonstrated significant progress. Finally, I have vetoed provisions that would have reverted four appropriations that are reauthorized in House Bill 5 of the 2010 Special Session. These actions were taken in consideration of the overall need for solvency in the current year.

I have this day SIGNED:
