11	RELATING TO PUBLIC SCHOOLS; CHANGING GRADUATION REQUIREMENTS
12	FOR STUDENTS ENTERING NINTH GRADE IN THE 2012-2013 SCHOOL YEAR
13	TO INCLUDE HEALTH EDUCATION; RECONCILING MULTIPLE AMENDMENTS TO
14	THE SAME SECTION OF LAW IN LAWS 2009.

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. Section 22-13-1.1 NMSA 1978 (being Laws 1986,
18	Chapter 33, Section 5, as amended by Laws 2009, Chapter 256,
19	Section 1 and by Laws 2009, Chapter 267, Section 2 and also by
20	Laws 2009, Chapter 268, Section 1) is amended to read:
21	"22-13-1.1. GRADUATION REQUIREMENTS
22	A. At the end of grades eight through eleven, each
23	student shall prepare an interim next-step plan that sets forth
24	the coursework for the grades remaining until high school
25	graduation. Each year's plan shall explain any differences

<u>underscored material = new</u> [<del>bracketed material</del>] = delete from previous interim next-step plans, shall be filed with the principal of the student's high school and shall be signed by the student, the student's parent and the student's guidance counselor or other school official charged with coursework planning for the student.

B. Each student must complete a final next-step plan during the senior year and prior to graduation. The plan shall be filed with the principal of the student's high school and shall be signed by the student, the student's parent and the student's guidance counselor or other school official charged with coursework planning for the student.

C. An individualized education program that meets the requirements of Subsections A and B of this section and that meets all applicable transition and procedural requirements of the federal Individuals with Disabilities Education Act for a student with a disability shall satisfy the next-step plan requirements of this section for that student.

D. A local school board shall ensure that each high school student has the opportunity to develop a next-step plan based on reports of college and workplace readiness assessments, as available, and other factors and is reasonably informed about:

(1) curricular and course options, including honors or advanced placement courses, dual-credit courses, distance learning courses, career clusters, pre-apprenticeship .180731.1

1 on grammar and literature; 2 (2) three units in mathematics, at least one 3 of which is equivalent to the algebra 1 level or higher; 4 (3) two units in science, one of which shall 5 have a laboratory component; provided, however, that with students entering the ninth grade beginning in the 2005-2006 6 7 school year, three units in science shall be required, one of which shall have a laboratory component; 8 9 three units in social science, which shall (4) 10 include United States history and geography, world history and 11 geography and government and economics; 12 one unit in physical education; (5) 13 one unit in communication skills or (6) 14 business education, with a major emphasis on writing and 15 speaking and that may include a language other than English; 16 one-half unit in New Mexico history for (7) 17 students entering the ninth grade beginning in the 2005-2006 18 school year; and 19 (8) nine elective units and seven and 20 one-half elective units for students entering the ninth grade 21 in the 2005-2006 school year that meet department content and 22 performance standards. Student service learning shall be 23 offered as an elective. Financial literacy shall be offered as 24 an elective. Pre-apprenticeship programs may be offered as 25 electives. Media literacy may be offered as an elective.

G. For students entering the ninth grade beginning in the 2009-2010 school year, at least one of the units required for graduation shall be earned as an advanced placement or honors course, a dual-credit course offered in cooperation with an institution of higher education or a distance learning course.

H. The department shall establish a procedure for students to be awarded credit through completion of specified career technical education courses for certain graduation requirements.

I. Successful completion of the requirements of the New Mexico diploma of excellence shall be required for graduation for students entering the ninth grade beginning in the 2009-2010 school year. Successful completion of a minimum of twenty-four units aligned to the state academic content and performance standards shall be required to earn a New Mexico diploma of excellence. These units shall be as follows:

(1) four units in English, with major emphasison grammar, nonfiction writing and literature;

(2) four units in mathematics, of which one shall be the equivalent to or higher than the level of algebra2, unless the parent submitted written, signed permission for the student to complete a lesser mathematics unit;

(3) three units in science, two of which shall have a laboratory component;

graduation examination on social science shall include a section on the constitution of the United States and the constitution of New Mexico. If a student exits from the school system at the end of grade twelve without having passed a state graduation examination, the student shall receive an appropriate state certificate indicating the number of credits earned and the grade completed. If within five years after a student exits from the school system the student takes and passes the state graduation examination, the student may receive a high school diploma. Any student passing the state graduation examination and completing all other requirements within five years of entering ninth grade, including a final summer session if completed by August 1, may be counted by the school system in which the student is enrolled as a high school graduate for the year in which completion and examination occur.

[L.] M. Beginning with the 2010-2011 school year, a student shall not receive a New Mexico diploma of excellence if the student has not demonstrated competence in the subject areas of mathematics, reading and language arts, writing, social studies and science, including a section on the constitution of the United States and the constitution of New Mexico, based on a standards-based assessment or assessments or a portfolio of standards-based indicators established by the department by rule. 1 in Section 22-2C-4 NMSA 1978 may also serve as the assessment 2 required for high school graduation. If a student exits from 3 the school system at the end of grade twelve without having 4 satisfied the requirements of this subsection, the student 5 shall receive an appropriate state certificate indicating the 6 number of credits earned and the grade completed. If within 7 five years after a student exits from the school system the 8 student satisfies the requirement of this subsection, the 9 student may receive a New Mexico diploma of excellence. Any 10 student satisfying the requirements of this subsection and 11 completing all other requirements within five years of entering 12 ninth grade, including a final summer session if completed by 13 August 1, may be counted by the school system in which the 14 student is enrolled as a high school graduate for the year in 15 which all requirements are satisfied.

[M.] N. As used in this section:

(1) "final next-step plan" means a next-step plan that shows that the student has committed or intends to commit in the near future to a four-year college or university, a two-year college, a trade or vocational program, an internship or apprenticeship, military service or a job;

(2) "interim next-step plan" means an annual next-step plan in which the student specifies post-high-school goals and sets forth the coursework that will allow the student to achieve those goals; and
