11	MAKING AN APPROPRIATION TO PLACE ECONOMIC DEMOGRAPHERS IN THE

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. APPROPRIATION
18	A. Four hundred thousand dollars (\$400,000) is
19	appropriated from the general fund to the economic development
20	department for expenditure in fiscal year 2011 to work in
21	conjunction with the department of environment and the
22	workforce solutions, public education and tourism departments
23	to provide for economic demographers for the state's planning
24	districts to pioneer the development of a predictive model to
25	forecast the demographic and economic futures of local

2	(1) in the eastern plains, to cover Curry, De
2	Baca, Guadalupe, Harding, Quay, Roosevelt and Union counties;
4	(2) in the central mid-region, to cover
5	Bernalillo, Sandoval, Torrance and Valencia counties and some
6	portions of Santa Fe county;
7	(3) in the north central region, to serve
8	Colfax, Los Alamos, Mora, Rio Arriba, San Miguel and Taos
9	counties and some parts of Sandoval and Santa Fe counties;
10	(4) in the northwest area, to serve Cibola,
11	McKinley and San Juan counties;
12	(5) in the south central area, to serve
13	Sierra, Socorro and Dona Ana counties;
14	(6) in the southeastern region, to serve
15	Chaves, Eddy, Lea, Lincoln and Otero counties; and
16	(7) in the southwest, to serve Catron, Grant,
17	Hidalgo and Luna counties.
18	B. The economic development department may retain
19	up to ten percent of the appropriation for administrative costs
20	associated with the demographers and shall report to the
21	appropriate interim legislative committee on the demographers'
22	progress by November 2010.
23	C. Any unexpended or unencumbered balance remaining
24	at the end of fiscal year 2011 shall revert to the general
25	fund.
