- 5. On page 22, lines 11 though 14, remove the brackets and line through.
- 6. On page 22, line 14, before "shall" insert "and any increment that is imposed with an effective date on or after July 1, 2010 but before July 1, 2014".
- 7. On page 23, lines 13 and 14, remove the brackets and the line through.

- 12. On page 29, line 3, after "tax" insert "with an effective date on or after July 1, 2010 but before July 1, 2014".
- 13. On page 30, line 9, after "tax" insert "with an effective date on or after July 1, 2010 but before July 1, 2014".
- 14. On page 32, line 7, after "tax" insert "with an effective date on or after July 1, 2010 but before July 1, 2014".
