"[<u>NEW MATERIAL</u>] HISPANIC EDUCATION ADVISORY COUNCIL.--

A. The "Hispanic education advisory council" is created as an advisory council to the secretary. The council shall advise the secretary on matters related to improving public school education for Hispanic students, increasing parent involvement and community

engagement in the education of Hispanic students and increasing the number of Hispanic high school graduates who succeed in postsecondary academic, professional or vocational education.

B. The secretary shall appoint members to the council who are knowledgeable about and interested in the education of Hispanic students, including representatives of public schools; postsecondary education and teacher preparation programs; parents; Hispanic cultural, community and business organizations; other community and business organizations; and other interested persons. The secretary shall give due regard to geographic representation. Members serve at the pleasure of the secretary.

C. The council shall elect a chairperson and such other officers as it deems necessary.

D. The council shall meet as necessary, but at least twice each year.

E. The council shall advise the secretary on matters related to Hispanic education in New Mexico.

F. Members of the council shall not receive per diem and mileage or other compensation for their services."".

8. Renumber the succeeding sections accordingly.

9. On page 3, line 20, strike "office" and insert in lieu thereof "department".
