two million one hundred six thousand six hundred ninety-six dollars (\$2,106,696) to plan, design and construct water system improvements for the Fambrough mutual domestic water consumers association in Chaves county

#### HAGERMAN WATER STORAGE TANK

two hundred thirty thousand dollars (\$230,000) to plan, design, construct, equip and improve a potable water storage tank for Hagerman in Chaves county

seventy thousand dollars (\$70,000) to purchase construction equipment, including a backhoe, for the Rolling Hills community water users association in Otero county
