SUMMARY

Synopsis of Bill

Senate Bill 196 appropriates fifty thousand dollars (\$50,000) from the General Fund to the Indian Affairs Department for the purpose of contracting to provide direct services, including advocacy, counseling and assistance in filing protection orders, to low income victims of domestic violence in New Mexico communities of the Navajo Nation.

FISCAL IMPLICATIONS

The appropriation of \$50 thousand contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2011 shall revert to the general fund.

SIGNIFICANT ISSUES

According to IAD, SB 196 could provide funding for counseling and direct services through the Navajo Nation's Office for Women and Families for victims of domestic violence. The OWF provides advocacy and referral services for low-income women and children who experience domestic violence on the Navajo Nation. Native American women experience the highest rates of Intimate Partner Violence of any ethnic group in the United States.

PERFORMANCE IMPLICATIONS

CYFD has performance measures related to adult victims receiving domestic violence services.
