I request that the following be funded:

- to the aging and long-term services department

TORREON-STAR LAKE CHP SENIOR CTR

four hundred twelve thousand two hundred fifteen dollars (\$412,215) to construct the senior center at the Torreon-Star Lake chapter within the eastern Navajo agency of the Navajo Nation in Sandoval county

- to the Indian affairs department

OJO ENCINO CHP HOUSE RENOVATE

one hundred fifty thousand dollars (\$150,000) to plan, design, construct and renovate the chapter house in the Ojo Encino chapter of the Navajo Nation in Sandoval and McKinley counties

OJO ENCINO CHP POWERLINES

three hundred forty-three thousand two hundred dollars (\$343,200) to plan, design and construct powerlines in the Ojo Encino chapter of the Navajo Nation in Sandoval and McKinley counties

OJO ENCINO CHP RURAL ADDRESSING FOR 911 SYSTEM

fifty thousand dollars (\$50,000) to develop a rural addressing system to number houses and roads for the 911 system in the Ojo Encino chapter of the Navajo Nation in Sandoval and McKinley counties

OJO ENCINO CHP WAREHOUSE

one hundred thousand dollars (\$100,000) to plan, design and construct a warehouse in the Ojo Encino chapter of the Navajo Nation in Sandoval and McKinley counties

thirty-five thousand dollars (\$35,000) to purchase and equip vehicles for five Sandoval Indian pueblos in Sandoval county

COCHITI PUEBLO BRUSH FIRE TRUCK

one hundred fifty-five thousand dollars (\$155,000) to purchase and equip a brush fire truck for the Pueblo of Cochiti in Sandoval county

COCHITI PUEBLO CORE VILLAGE REVITALIZATION

six hundred seventeen thousand dollars (\$617,000) to plan, design and construct the core village revitalization project in the Pueblo of Cochiti in Sandoval county

COCHITI PUEBLO LANGUAGE & CULTURAL BLDG

four hundred forty-six thousand dollars (\$446,000) to plan, design and construct a language and cultural building in the Pueblo of Cochiti in Sandoval county

COCHITI PUEBLO MAINTENANCE FACILITY

four hundred ninety-nine thousand dollars (\$499,000) to relocate and construct a maintenance building in the Pueblo of Cochiti in Sandoval county

COCHITI PUEBLO MULTIUSE FACILITY

four hundred eighty-four thousand four hundred sixty-five dollars (\$484,465) to plan, design and renovate the multiuse facility in the Pueblo of Cochiti in Sandoval county

COCHITI PUEBLO VISITORS' CTR

one million one hundred twenty-four thousand dollars (\$1,124,000) to plan, design, construct and equip a visitors' center in the Pueblo of Cochiti in Sandoval county

JEMEZ PUEBLO IRRIGATION SYSTEM IMPROVE

fifty thousand dollars (\$50,000) to plan, design and construct improvements to the irrigation system, including head gates, in the Pueblo of Jemez in Sandoval county

JEMEZ PUEBLO POLICE DEPT PARKING LOT

fifty thousand dollars (\$50,000) to construct improvements to the police department parking lot, including paving, handicapped access and landscaping, in the Pueblo of Jemez in Sandoval county

one hundred fifty thousand dollars (\$150,000) to construct, furnish and equip an effluent storage pond at the Pueblo of Santa Ana in Sandoval county

SANTA ANA PUEBLO FIRE, EMS, POLICE SUBSTATION

six hundred thousand dollars (\$600,000) to plan, design, construct, furnish and equip a fire and emergency medical services facility and police substation in the Pueblo of Santa Ana in Sandoval county

SANTA ANA PUEBLO MULTIPURPOSE ED & WELLNESS CTR

six million three hundred thousand dollars (\$6,300,000) to design, construct, furnish and equip a multipurpose education and wellness center in the Pueblo of Santa Ana in Sandoval county

SANTA ANA PUEBLO WWATER TREATMENT PLANT IMPROVE

three million four hundred fifty thousand dollars (\$3,450,000) to plan, design, construct, furnish and equip improvements to the wastewater treatment plant in the Pueblo of Santa Ana in Sandoval county

SANTO DOMINGO PUEBLO FIRE TRUCKS/EQUIP

six hundred thousand dollars (\$600,000) to purchase pumper and tender trucks and equip the Kewa fire, emergency medical services and safety complex at the Pueblo of Santo Domingo in Sandoval county

TORREON-STAR LAKE CHP CLINIC

one hundred thousand dollars (\$100,000) to plan, design and construct a clinic in the Torreon-Star Lake chapter within the eastern Navajo agency in Sandoval county

TORREON-STAR LAKE CHP MULTIPRPS BLDG

one hundred thousand dollars (\$100,000) to plan, design and construct a multipurpose building for the Torreon-Star Lake chapter within the eastern Navajo agency in Sandoval county

TORREON-STAR LAKE CHP POWERLINE PROJECT

fifty thousand dollars (\$50,000) to plan, design and construct a scattered electric powerline project in the Torreon-Star Lake chapter of the Navajo Nation in McKinley and Sandoval counties

one hundred thousand dollars (\$100,000) to plan, design and construct water line extensions in the Cayaditto camp and Torreon south areas of the Torreon-Star Lake chapter of the Navajo Nation in Sandoval and McKinley counties

SANTA FE INDIAN SCHL CLASSROOMS

four million seven hundred seventy-seven thousand dollars (\$4,777,000) to plan, design and construct classroom space for computer-aided drafting and design, welding, carpentry and woodworking, at Santa Fe Indian school in Santa Fe county

SANTA FE INDIAN SCHL CLINICAL CLASSRM HEALTH FCLTY

two million dollars (\$2,000,000) to plan, design and construct a clinical classroom health facility at Santa Fe Indian school in Santa Fe county

MCKINLEY CO ROAD DEPT GRADERS & EQUIPMENT

five hundred twenty-five thousand dollars (\$525,000) to purchase and equip road graders and to purchase heavy equipment for the county road department in McKinley county

MCKINLEY CO REGIONAL JUDICIAL COMPLEX

seven hundred thousand dollars (\$700,000) to purchase, construct, equip and furnish a regional judicial complex, including a shared facility with both magistrate and municipal courts, DWI office, drug courts, public defenders' office and other services, in Gallup in McKinley county

one hundred thousand dollars (\$100,000) to plan, design and construct improvements and paving to Horse Canyon road in the Torreon-Star Lake chapter within the eastern Navajo agency in McKinley county

RAIL RUNNER AVE EXTENSION-BERNALILLO

fifty-five thousand dollars (\$55,000) to plan and design an extension of Rail Runner avenue to provide access to Bernalillo high school off of United States highway 550 in Bernalillo in Sandoval county
