CAPITAL PROJECTS FOR SENATOR CLINTON D. HARDEN

I request that the following be funded:

- to the department of environment

**RATON SOLID WASTE TRANSFER STATION/RECYCLE CTR**

five hundred thousand dollars (\$500,000) to construct and equip the municipal solid waste transfer station and recycling center in Raton in Colfax county

**TUCUMCARI TRASH COLLECTION TRUCKS**

one hundred fifty thousand dollars (\$150,000) to purchase trash collection trucks for the solid waste department in Tucumcari in Quay county

**SAN MIGUEL CO SOLID WASTE BALER**

two hundred fifty thousand dollars (\$250,000) to purchase and equip a solid waste baler in San Miguel county

- to the interstate stream commission

**RIO COSTILLA ASSOCIATION DITCH IMPROVE**

one million three hundred sixty thousand six hundred sixty-five dollars (\$1,360,665) to plan, design and construct improvements, including a pipeline, to the Rio Costilla association ditch in Taos county

- to the local government division of the department of finance and administration

**RATON REGIONAL AQUATIC CTR PARKING LOT**

two hundred fifty thousand dollars (\$250,000) to construct a parking lot for the regional aquatic center in Raton in Colfax county

### CURRY CO ADULT DETENTION CENTER RENOVATE

two million dollars (\$2,000,000) to plan, design, construct and renovate the adult detention center in Clovis in Curry county

### CURRY CO COURTHOUSE RENOVATE

two million dollars (\$2,000,000) to plan, design, construct, improve and renovate the courthouse in Clovis in Curry county

### QUAY CO DETENTION CTR PLUMBING/HVAC

two hundred fifty thousand dollars (\$250,000) to replace the plumbing and heating, ventilation and air conditioning system in the detention center in Quay county

### SAN MIGUEL CO DETENTION CTR ADULT REINTEGRATION

one hundred thousand dollars (\$100,000) to plan and design a community-based adult reintegration center at the county detention center in Las Vegas in San Miguel county

### SAN MIGUEL CO COURTHOUSE WINDOWS

three hundred fifty thousand dollars (\$350,000) to replace windows at the county courthouse in Las Vegas in San Miguel county

### CERRO FIRE STATION IMPROVE

three hundred fifty thousand dollars (\$350,000) to plan, design, construct and improve the Cerro fire station in Taos county

### CURRY CO ROADS IMPROVE

two million dollars (\$2,000,000) to plan, design and construct road improvements in the Cannon air force base area and north and east of Clovis in Curry county

### CLOVIS STREETS & MEDIANS IMPROVE

one million dollars (\$1,000,000) to plan, design, construct and equip street and median improvements in Clovis in Curry county

### SAN MIGUEL CO ROADS IMPROVE

four hundred eleven thousand three hundred twenty-six dollars (\$411,326) to plan, design and construct improvements, including chip seal, to county roads in San Miguel county
