WHEREAS, Section 13-6-2 NMSA 1978 provides that a state agency may sell or otherwise dispose of real property by negotiated sale or donation to a local public body; and

WHEREAS, Section 13-6-3 NMSA 1978 provides that any 9 sale, trade or lease for a period exceeding twenty-five years 10 11 in duration of real property belonging to any state agency, which sale, trade or lease shall be for a consideration of 12 one hundred thousand dollars (\$100,000) or more, shall be 13 subject to the ratification and approval of the state 14 15 legislature prior to the sale, trade or lease becoming effective; and 16

WHEREAS, the property control division of the general services department owns real property located at 206 Don Pasqual road, Los Lunas, New Mexico, more particularly described as:

"MAP 73 TRACT 9A1B CONTAINING 9.35 ACRES, MAP 69 TRACT
60 CONTAINING 1.38 ACRES and MAP 69 TRACT 107B CONTAINING
13.30 ACRES"; and

WHEREAS, the Los Lunas public school district currently uses the real property for use as the Katherine Gallegos elementary school; and

WHEREAS, the real property has a value in excess of one hundred thousand dollars (\$100,000);

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the proposed transfer of the real property at 206 Don Pasqual road, Los Lunas, New Mexico, from the state to the Los Lunas public school district be hereby ratified and approved by the legislature; and

BE IT FURTHER RESOLVED that the authorization be contingent upon agreement by the parties in the conveyance document that if the Los Lunas public school district ever decides that the property is no longer needed for the Katherine Gallegos elementary school and should be disposed of, at the option of the state and at no cost to the state, the property shall be reconveyed by the Los Lunas public school district to the state; and

BE IT FURTHER RESOLVED that the property shall not be sold or transferred until it has been reviewed by the capitol buildings planning commission; and
