#### Synopsis of Bill

House Bill 7 represents the Legislative Finance Committee recommendation for funding the FY12 recurring operations of state government. It appropriates general fund, other state funds, internal service funds/interagency transfers and federal funds for the operation of state agencies, higher education and public school support. See the fiscal implications section of this report for the breakout of appropriations between recurring and nonrecurring funding sources.

- 1. <u>Section 4, Fiscal Year 2012 Appropriations (pages 6 through 202)</u>. This section provides funding for state agencies, higher education and public school support.
- 2. <u>Section 5 Special Appropriations (page 202), Section 6, Supplemental and Deficiency Appropriations (pages 202-204) and Section 7 Data Processing Appropriations (pages 204-205).</u>
  - Section 5 appropriates money for expenditure in FY11 and FY12 for various special purposes.
  - Section 6 appropriates money for expenditure in FY11 to make up shortfalls in FY10 and projected shortfalls in FY11.
  - Section 7 appropriates money for expenditure in FY11-FY13 for various expenditures relating to computer systems.
