# Synopsis of Bill

House Bill 437 is the implementing legislation for Constitutional Amendment #4 approved last November by the voters. CA #4 was put on the ballot by the passage last session of SJR 7, introduced by David Ulibarri and Jeff Steinborn. The voters statewide approved the proposal 58% to 42%.

## House Bill 437 – Page 2

The bill provides that the property of a veteran's organization chartered by the United States Congress that is used primarily for the benefit of veterans and their families is exempt from property taxation.

The bill outlines the procedures that veterans' organizations must use to claim the exemption.

The exemption begins with property tax years beginning on or after January 1, 2012.

## FISCAL IMPLICATIONS

VSA notes that there are 175 properties owned by chartered veterans' service organizations. Assume half of these are in Bernalillo County (average taxable value \$200K and average NR property tax rate of 45 mills) and half are distributed throughout the state (average taxable value \$150K and average NR property tax rate of 30 mills). The burden shift from veterans' organizations to other non-residential properties will be about \$1.2 million statewide. No burden will shift to residential properties.

# **OTHER SUBSTANTIVE ISSUES**

Apparently, there are at least 52 veterans' service organizations chartered by the U.S. Congress. A list is attached to this FIR as Appendix A.

Last year, TRD commented on the Joint Memorial:

The proposed measure would provide another property tax-related benefit to veterans and their families. Veterans are currently provided several specific property tax benefits by the New Mexico Constitution and Property Tax Code – Articles 35 through 38 of NMSA 1978. These include a \$4,000 exemption in net taxable value of real property subject to valuation under the Property Tax Code, as well as a total exemption from property taxes on property owned and occupied taxes among veterans that are 100 percent disabled by virtue of having served in U.S. armed forces. Veterans may also benefit from the property tax rebates and the Low Income Comprehensive Tax Rebate (which are also available to non-veterans).
