SIGNIFICANT ISSUES

HB550 proposes creation of a new division that would be responsible for outreach to Native American Veterans and Native American Veteran Organizations, act as a liaison for Native American Veterans the local, state and federal governments, and assist Native American Veterans advocate and apply for all state and federal benefits afforded to them by law.
