18	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
19	SECTION 1. SHORT TITLEThis act may be cited as the
20	"2011 House Redistricting Act".
21	SECTION 2. MEMBERSHIPThe house of representatives is
22	composed of seventy members to be elected from districts that
23	are contiguous and that are as compact as is practical.
24	SECTION 3. RESIDENCEAt the time of filing a
25	declaration of candidacy for the office of state

1 representative, a candidate shall reside in the district for 2 which the candidate files. Thereafter, if a representative 3 permanently removes the representative's residence from or maintains no residence in the district from which the 4 representative was elected, the representative shall be deemed 5 to have resigned and a successor shall be selected as provided 6 7 in Section 4 of the 2011 House Redistricting Act. SECTION 4. ELECTIONS--VACANCIES.--8 9 Α. Members of the house of representatives shall be elected for terms of two years. 10 If a vacancy occurs in the office of 11 Β. 12 representative for any reason, the vacancy shall be filled as follows: 13 14 (1)for a representative district that is situated wholly within the exterior boundaries of a single 15 county, the board of county commissioners of that county shall 16 appoint the representative to fill the vacancy; and 17 18 (2) for a representative district situated 19 within two or more counties: 20 (a) the board of county commissioners of each county in the representative district shall submit one 21 name to the governor; and 22 the governor shall appoint the (b) 23 representative to fill the vacancy from the list of names so 24 25 submitted. .186983.1

C. An appointment to fill a vacancy in the house of representatives shall be for a term ending on December 31 after the next general election.

D. An appointment to fill a vacancy made before the general election of 2012 shall be made from the district as it was described in Section 2-7D-1 NMSA 1978 (as established by the court in Jepsen v. Vigil-Giron, D-0101-CV-2001-02177 (1st Dist. Ct., filed January 28, 2002)). After the general election of 2012, a vacancy shall be filled by appointment from the district as set out in the 2011 House Redistricting Act. SECTION 5. PRECINCTS.--

A. Precinct designations and boundaries used in the 2011 House Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of August 31, 2011.

B. A board of county commissioners shall not create any precinct that lies in more than one representative district and shall not divide any precinct so that the divided parts of the precinct are situated in two or more representative districts. Votes cast in a statewide election from precincts created or divided in violation of this subsection are invalid and shall not be counted or canvassed.

SECTION 6. DISTRICTS.--The districts of the house of representatives shall be as set out in Sections 7 through 76 of .186983.1
