AN ACT

RELATING TO CONGRESSIONAL REDISTRICTING; ESTABLISHING
CONGRESSIONAL DISTRICTS FOR THE ELECTION OF REPRESENTATIVES TO
THE UNITED STATES CONGRESS; CHANGING PROVISIONS OF THE ELECTION
CODE RELATING TO PRECINCTS; AMENDING, REPEALING AND ENACTING
SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 1-15-15 NMSA 1978 (being Laws 1969,
Chapter 240, Section 365, as amended) is amended to read:

"1-15-15. UNITED STATES REPRESENTATIVE--CONGRESSIONAL
DISTRICTS ESTABLISHED.--New Mexico is divided into three
congressional districts to be known and designated as
congressional district [~~number~~] one, congressional district
[~~number~~] two and congressional district [~~number~~] three."

16 pursuant to that act by the secretary of state as of [~~August~~
17 ~~16, 1991~~] August 31, 2011.

18 B. The boards of county commissioners shall not
19 create any precinct that lies in more than one congressional
20 district, nor shall the boards of county commissioners divide
21 any precinct so that the divided parts of the precinct are
22 situated in two or more congressional districts. Votes cast in
23 any general, primary or other statewide election from precincts
24 created or divided in violation of this subsection shall be
25 invalid and shall not be counted or canvassed."
