11	RELATING TO THE REDISTRICTING OF THE SENATE; ESTABLISHING
12	SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING
13	SENATORS; PROVIDING FOR THE FILLING OF VACANCIES; SETTING
14	PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF SENATORS;
15	REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. SHORT TITLEThis act may be cited as the
19	"2011 Senate Redistricting Act".
20	SECTION 2. MEMBERSHIPThe senate is composed of forty-
21	two members to be elected from districts that are contiguous
22	and that are as compact as is practical.
23	SECTION 3. RESIDENCEAt the time of filing a
24	declaration of candidacy for the office of state senator, the
25	candidate shall reside in the district for which the candidate

1 files. Thereafter, if a senator permanently removes the 2 senator's residence from or maintains no residence in the district from which the senator was elected, the senator shall 3 be deemed to have resigned and the senator's successor shall be 4 selected as provided in Section 4 of the 2011 Senate 5 Redistricting Act. 6 7 SECTION 4. ELECTIONS--VACANCIES.--8 Members of the senate shall be elected for terms Α. 9 of four years. If a vacancy occurs in the office of senator for 10 Β. any reason, the vacancy shall be filled as follows: 11 12 (1)for a senate district that is situated 13 wholly within the exterior boundaries of a single county, the 14 board of county commissioners of that county shall appoint the senator to fill the vacancy; and 15 for a senate district situated within two 16 (2)17 or more counties: 18 the board of county commissioners of (a) 19 each county in the senate district shall submit one name to the 20 governor; and the governor shall appoint the 21 (b) senator to fill the vacancy from the list of names so 22 submitted. 23 C. All appointments to fill vacancies in the senate 24 25 shall be for a term ending on December 31 subsequent to the .187440.1 - 2 -

next succeeding general election, at which general election a person shall be elected to fill the remainder of the unexpired term.

D. An appointment to fill a vacancy made before the general election of 2012 shall be made from the district as it was described in Laws 2002, Chapter 98, Sections 7 through 48. After the general election of 2012, a vacancy shall be filled by appointment from the district set out in the 2011 Senate Redistricting Act.

SECTION 5. PRECINCTS.--

A. Precinct designations and boundaries used in the 2011 Senate Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of August 31, 2011.

B. A board of county commissioners shall not create any precinct that lies in more than one senate district and shall not divide any precinct so that the divided parts of the precinct are situated in two or more senate districts. Votes cast in a statewide election from precincts created or divided in violation of this subsection are invalid and shall not be counted or canvassed.

SECTION 6. DISTRICTS.--The districts of the senate shall be as set out in Sections 7 through 48 of the 2011 Senate Redistricting Act.
