AN ACT

RELATING TO THE REDISTRICTING OF THE SENATE; ESTABLISHING
SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING
SENATORS; PROVIDING FOR THE FILLING OF VACANCIES; SETTING
PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF SENATORS;
REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. SHORT TITLE.--This act may be cited as the
"2011 Senate Redistricting Act".

SECTION 2. MEMBERSHIP.--The senate is composed of forty-
two members to be elected from districts that are contiguous
and that are as compact as is practical.

SECTION 3. RESIDENCE.--At the time of filing a
declaration of candidacy for the office of state senator, the
candidate shall reside in the district for which the candidate

1 files. Thereafter, if a senator permanently removes the
2 senator's residence from or maintains no residence in the
3 district from which the senator was elected, the senator shall
4 be deemed to have resigned and the senator's successor shall be
5 selected as provided in Section 4 of the 2011 Senate
6 Redistricting Act.

7 SECTION 4. ELECTIONS--VACANCIES.--

8 A. Members of the senate shall be elected for terms
9 of four years.

10 B. If a vacancy occurs in the office of senator for
11 any reason, the vacancy shall be filled as follows:

12 (1) for a senate district that is situated
13 wholly within the exterior boundaries of a single county, the
14 board of county commissioners of that county shall appoint the
15 senator to fill the vacancy; and

16 (2) for a senate district situated within two
17 or more counties:

18 (a) the board of county commissioners of
19 each county in the senate district shall submit one name to the
20 governor; and

21 (b) the governor shall appoint the
22 senator to fill the vacancy from the list of names so
23 submitted.

24 C. All appointments to fill vacancies in the senate
25 shall be for a term ending on December 31 subsequent to the

1 next succeeding general election, at which general election a
 2 person shall be elected to fill the remainder of the unexpired
 3 term.

4 D. An appointment to fill a vacancy made before the
 5 general election of 2012 shall be made from the district as it
 6 was described in Laws 2002, Chapter 98, Sections 7 through 48.
 7 After the general election of 2012, a vacancy shall be filled
 8 by appointment from the district set out in the 2011 Senate
 9 Redistricting Act.

10 SECTION 5. PRECINCTS.--

11 A. Precinct designations and boundaries used in the
 12 2011 Senate Redistricting Act are those precinct designations
 13 and boundaries established pursuant to the Precinct Boundary
 14 Adjustment Act and revised and approved pursuant to that act by
 15 the secretary of state as of August 31, 2011.

16 B. A board of county commissioners shall not create
 17 any precinct that lies in more than one senate district and
 18 shall not divide any precinct so that the divided parts of the
 19 precinct are situated in two or more senate districts. Votes
 20 cast in a statewide election from precincts created or divided
 21 in violation of this subsection are invalid and shall not be
 22 counted or canvassed.

23 SECTION 6. DISTRICTS.--The districts of the senate shall
 24 be as set out in Sections 7 through 48 of the 2011 Senate
 25 Redistricting Act.

1 **SECTION 7. SENATE DISTRICT ONE.**--Senate district one is
2 composed of San Juan county precincts 26 through 40, 43 through
3 46, 49 through 53, 55 and 56.

4 **SECTION 8. SENATE DISTRICT TWO.**--Senate district two is
5 composed of San Juan county precincts 21, 41, 42, 47, 48, 54
6 and 57 through 77.

7 **SECTION 9. SENATE DISTRICT THREE.**--Senate district three
8 is composed of McKinley county precincts 1 through 6, 19
9 through 21, 31, 34, 37, 38 and 41; and San Juan county
10 precincts 1 through 13, 17, 18, 20 and 22 through 25.

11 **SECTION 10. SENATE DISTRICT FOUR.**--Senate district four
12 is composed of Cibola county precincts 4, 6 and 15; and
13 McKinley county precincts 14, 16 through 18, 22 through 30, 32,
14 33, 35, 36, 39, 40, 42 through 50 and 52 through 59.

15 **SECTION 11. SENATE DISTRICT FIVE.**--Senate district five
16 is composed of Los Alamos county precincts 8 through 17; Rio
17 Arriba county precincts 1 through 14, 18 through 23, 28 and 31
18 through 42; and Santa Fe county precincts 58 and 79.

19 **SECTION 12. SENATE DISTRICT SIX.**--Senate district six is
20 composed of Los Alamos county precincts 1 through 7; Rio Arriba
21 county precincts 15 through 17; Sandoval county precinct 51;
22 Santa Fe county precincts 1 through 7, 23, 40, 59 through 61
23 and 87; and Taos county precincts 1 through 17, 19, 20, 22
24 through 25 and 27 through 36.

25 **SECTION 13. SENATE DISTRICT SEVEN.**--Senate district seven

1 is composed of Curry county precincts 1 through 3, 5, 9 through
2 28, 32 through 35 and 37; Quay county; and Union county.

3 SECTION 14. SENATE DISTRICT EIGHT.--Senate district eight
4 is composed of Colfax county; Guadalupe county; Harding county;
5 Mora county; San Miguel county precincts 1 through 17 and 25
6 through 28; and Taos county precincts 18, 21 and 26.

7 SECTION 15. SENATE DISTRICT NINE.--Senate district nine
8 is composed of Bernalillo county precincts 6 through 10, 18 and
9 86; and Sandoval county precincts 1 through 6, 11 through 13,
10 29, 31 through 33, 35, 36, 38, 52 through 57, 59, 64 and 76.

11 SECTION 16. SENATE DISTRICT TEN.--Senate district ten is
12 composed of Bernalillo county precincts 2, 3, 19, 68, 69, 78,
13 79, 84, 87, 89, 116, 170 and 171; and Sandoval county precincts
14 30, 42 through 46, 72, 85 and 86.

15 SECTION 17. SENATE DISTRICT ELEVEN.--Senate district
16 eleven is composed of Bernalillo county precincts 32, 41, 43,
17 44, 49, 50, 53, 56, 59, 60, 66, 71, 74 and 137 through 140.

18 SECTION 18. SENATE DISTRICT TWELVE.--Senate district
19 twelve is composed of Bernalillo county precincts 15, 45, 61
20 through 65, 67, 94, 95, 104, 105, 109, 121 through 125, 131
21 through 133, 135, 165, 166, 196, 197, 211, 212, 214 through
22 217, 221, 224 through 226, 344 through 347 and 455.

23 SECTION 19. SENATE DISTRICT THIRTEEN.--Senate district
24 thirteen is composed of Bernalillo county precincts 4, 5, 11
25 through 14, 16, 17, 21, 22, 30, 83, 108, 110, 150 through 154,

1 161 through 164, 180 through 187 and 191 through 195.

2 SECTION 20. SENATE DISTRICT FOURTEEN.--Senate district
3 fourteen is composed of Bernalillo county precincts 42, 52, 54,
4 58, 72, 73, 75 through 77, 88, 90 through 92, 96 through 99 and
5 141 through 144.

6 SECTION 21. SENATE DISTRICT FIFTEEN.--Senate district
7 fifteen is composed of Bernalillo county precincts 316, 371
8 through 375, 400 through 406, 408, 409, 411 through 417, 419
9 through 421, 431 through 446, 466 and 490 through 492.

10 SECTION 22. SENATE DISTRICT SIXTEEN.--Senate district
11 sixteen is composed of Bernalillo county precincts 101 through
12 103, 106, 107, 223, 241 through 246, 251 through 258, 271
13 through 274, 278, 281, 282, 313 through 315, 317, 341 through
14 343, 351 through 358 and 381 through 387.

15 SECTION 23. SENATE DISTRICT SEVENTEEN.--Senate district
16 seventeen is composed of Bernalillo county precincts 275, 283
17 through 287, 291, 292, 311, 312, 318, 321 through 324, 326
18 through 331, 477 and 478.

19 SECTION 24. SENATE DISTRICT EIGHTEEN.--Senate district
20 eighteen is composed of Bernalillo county precincts 407, 450,
21 451, 453, 461 through 465, 471 through 476, 481 through 484,
22 487, 488, 493 through 500, 502 through 504, 506 through 509,
23 511 through 515, 523, 528, 529, 538, 562 and 563.

24 SECTION 25. SENATE DISTRICT NINETEEN.--Senate district

8 through 527, 530 through 536, 540, 542 through 550, 561 and 564
9 through 566.

10 **SECTION 27. SENATE DISTRICT TWENTY-ONE.**--Senate district
11 twenty-one is composed of Bernalillo county precincts 410, 418,
12 422 through 427, 429, 447 through 449, 456, 485, 486, 489, 510,
13 537, 539, 541, 560, 567 through 569 and 601 through 603.

14 **SECTION 28. SENATE DISTRICT TWENTY-TWO.**--Senate district
15 twenty-two is composed of Bernalillo county precinct 31;
16 McKinley county precincts 7 through 13 and 15; Rio Arriba
17 county precincts 24 through 27, 29 and 30; San Juan county
18 precincts 14 through 16 and 19; and Sandoval county precincts 7

23 21 through 28, 31, 32, 35 and 36.

24 **SECTION 36. SENATE DISTRICT THIRTY.**--Senate district
25 thirty is composed of Cibola county precincts 1 through 3, 5, 7

4 **SECTION 37. SENATE DISTRICT THIRTY-ONE.**--Senate district

7 **SECTION 38. SENATE DISTRICT THIRTY-TWO.**--Senate district
8 thirty-two is composed of Chaves county precincts 14 through
9 16, 23, 24, 31 through 34, 42, 43, 51, 52, 61 through 63, 71,
10 72, 81, 82, 90 through 92, 94 and 101 through 104; Eddy county
11 precincts 2, 3 and 41; Lincoln county precinct 11; and Otero
12 county precinct 11.

13 **SECTION 39. SENATE DISTRICT THIRTY-THREE.**--Senate

16 county precincts 2, 4 through 10, 12, 15, 17, 18, 20 and 21;

19 **SECTION 40. SENATE DISTRICT THIRTY-FOUR.**--Senate district

21 county precincts 17, 18, 26 through 30, 34, 35 and 45; and
22 Otero county precincts 1 through 9, 16 through 24, 26, 32, 34
23 through 36 and 41.

24 **SECTION 41. SENATE DISTRICT THIRTY-FIVE.**--Senate district

12 8, 16, 17, 37 through 40, 45, 48 through 58, 68 through 73, 78,
13 82, 94, 98, 101, 103, 104 and 113.

14 SECTION 45. SENATE DISTRICT THIRTY-NINE.--Senate district
15 thirty-nine is composed of Bernalillo county precinct 551;
16 Lincoln county precincts 1, 3, 13, 14, 16 and 19; San Miguel
17 county precincts 18 through 24; Santa Fe county precincts 12,

4 **SECTION 48. SENATE DISTRICT FORTY-TWO.**--Senate district
5 forty-two is composed of Chaves county precinct 47; Eddy county
6 precincts 1, 4 through 8, 19 through 21, 25, 36 through 40 and
7 42; and Lea county precincts 10, 13, 18, 20 through 30, 32, 33
8 and 41 through 44.

9 **SECTION 49. ELECTION OF SENATORS.**--Senators shall be
10 elected from the districts described in the 2011 Senate
11 Redistricting Act at the 2012 and subsequent general elections.

12 **SECTION 50. REPEAL.**--Sections 2-8D-1 through 2-8D-49 NMSA
13 1978 (being Laws 2002, Chapter 98, Sections 1 through 49) are
14 repealed.
