AN ACT

RELATING TO BOARDS AND COMMISSIONS; EXTENDING THE SUNSET DATES
FOR CERTAIN BOARDS AND COMMISSIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 60-2A-30 NMSA 1978 (being Laws 1980,
Chapter 90, Section 30, as amended) is amended to read:

"60-2A-30. TERMINATION OF AGENCY LIFE--DELAYED
REPEAL.--The New Mexico athletic commission is terminated on
July 1, [~~2011~~] 2017 pursuant to the Sunset Act. The commission
shall continue to operate according to the provisions of the
Professional Athletic Competition Act until July 1, [~~2012~~]
2018. Effective July 1, [~~2012~~] 2018, Chapter 60, Article 2A
NMSA 1978 is repealed."

SECTION 2. Section 61-14-1 NMSA 1978 (being Laws 1967,
Chapter 62, Section 1) is amended to read:
