I request that the following be funded:

- to the capital program fund

TAOS MARY MEDINA BLDG RENOVATE

two hundred thousand dollars (\$200,000) to plan, design, construct and renovate the Mary Medina building for a multiuse facility for law enforcement in Taos in Taos county

- to the office of the state engineer

QUESTA WATER RIGHTS

one hundred thousand dollars (\$100,000) to plan and purchase water rights for Questa in Taos county

- to the department of environment

TAOS CO TRANSFER STATION WEIGHT SCALES

two hundred eighty-eight thousand dollars (\$288,000) to construct, purchase and install weight scales at transfer stations in Taos county

CHAMISAL MDWCA FENCING

twenty-five thousand dollars (\$25,000) to purchase, install and construct fencing for the Chamisal mutual domestic water consumers association in Taos county

EL PRADO WSD WATER SYSTEM/WELL IMPROVE

fifty thousand dollars (\$50,000) to construct water system and well infrastructure improvements for El Prado water and sanitation district in Taos county

### QUESTA WATER WELL

one hundred thousand dollars (\$100,000) to plan, design and construct a water well in Questa in Taos county

### EL VALLE DE LOS RANCHOS WSD WASTEWATER SYSTEM

eight hundred sixty-five thousand dollars (\$865,000) to construct a wastewater collection and treatment system for El Valle de los Ranchos water and sanitation district in Taos county

### RED RIVER WATER & SEWER INFRA IMPROVE

three hundred thirty thousand dollars (\$330,000) to plan, design and construct improvements to the water and sewer system infrastructure in Red River in Taos county

### RED RIVER WATER SYSTEM IMPROVE

two hundred fifty thousand dollars (\$250,000) to plan, design, construct and equip improvements and to purchase and install information technology and related infrastructure for the water system in Red River in Taos county

- to the interstate stream commission

### ACEQUIA DEL MONTE DEL RIO CHIQUITO IMPROVE

one hundred eighty-two thousand dollars (\$182,000) to design and construct improvements to the acequia del Monte del Rio Chiquito in Talpa in Taos county

### ACEQUIA MADRE RIO LUCERO/ARROYO SECO/M.A. TRUJILLO

one million five hundred thirty thousand dollars (\$1,530,000) for the acquisition of water rights and land for the acequia Madre del Rio Lucero y Arroyo Seco and the upper and lower Manuel Andres Trujillo ditches in Taos county

### RIO COSTILLA ASSOCIATION DITCH IMPROVE

one million three hundred sixty thousand six hundred sixty-five dollars (\$1,360,665) to plan, design and construct improvements, including a pipeline, to the Rio Costilla association ditch in Taos county

### TALPA IRRIGATION RESERVOIR IMPROVE

three hundred thousand dollars (\$300,000) to construct improvements to the irrigation reservoir in Talpa in Taos county

one hundred thousand dollars (\$100,000) to plan, design, construct and renovate the Ponce de Leon hot springs in the Cristobal de la Serna land grant in Ranchos de Taos in Taos county

### TALPA CMTY CTR IMPROVE

one hundred thousand dollars (\$100,000) to plan, design, construct and equip improvements to the community center, including fencing, windows, stucco and parking area improvements, in Talpa in Taos county

### TAOS CO ECON DVLP BUSINESS & INDUSTRIAL PARK

forty thousand dollars (\$40,000) to renovate and repair the Taos county economic development business and industrial park, including the mobile livestock slaughtering unit and processing facilities, in Taos county

### TAOS CO SHERIFF DEPT PATROL UNITS & INFO TECH

one hundred fifty thousand dollars (\$150,000) to purchase patrol units and patrol unit information technology for the sheriff's department in Taos county

### TAOS CO TRUCKS/VEHICLES/EQUIP/MACHINERY

one hundred fifty thousand dollars (\$150,000) to purchase trucks, vehicles, equipment and machinery for Taos county

### AMALIA CMTY CENTER CONSTRUCT

seventy-five thousand dollars (\$75,000) to plan, design, construct, equip and furnish the community center in Amalia in Taos county

### CERRO FIRE STATION IMPROVE

three hundred fifty thousand dollars (\$350,000) to plan, design, construct and improve the Cerro fire station in Taos county

### PENASCO AMBULANCE BLDG

three hundred thousand dollars (\$300,000) to plan, design, construct and acquire an ambulance building for the Penasco ambulance department in Taos county

### QUESTA BUSINESS PARK WATER/SEWER/RDS IMPROVE

one hundred thousand dollars (\$100,000) to plan, design and construct water, sewer and road improvements to the business park in Questa in Taos county

one hundred thousand dollars (\$100,000) to plan, design and construct a multipurpose building in Questa in Taos county

### QUESTA MUNICIPAL BLDG IMPROVE

one hundred thousand dollars (\$100,000) to plan, design, construct and improve the municipal building in Questa in Taos county

### RED RIVER INFRASTRUCTURE CONSTRUCT

three hundred fifty thousand dollars (\$350,000) to plan, design and construct infrastructure, including replacing pavement in access and entrance roads and parking lots, in Red River in Taos county

### TAOS CO ROADS BASE COURSE MATERIAL

two hundred thousand dollars (\$200,000) to purchase and place base course material on county roads in Taos county

### TAOS CO ROADS IMPROVE

four million two hundred thousand dollars (\$4,200,000) to plan, design and construct improvements to roads in Taos county

### TAOS CO TRAFFIC SIGNALS ALBRIGHT/PASEO, TEWA/PASEO

one million dollars (\$1,000,000) to plan, design, construct, purchase and install coordinated traffic signals at the intersection of Albright street and Paseo and at the intersection of Tewa street and Paseo, including medians and signage, in Taos county
