I request that the following be funded:

- to the department of environment

MCKINLEY CO WATER SYSTEM IMPROVEMENTS

fifty thousand dollars (\$50,000) to plan, design and construct water system improvements for the communities of Rehoboth, Yah-ta-hey, Williams Acres, Gamerco and Ramah in McKinley county

- to the Indian affairs department

FORT DEFIANCE LONG-TERM CARE FACILITY

one hundred thousand dollars (\$100,000) to plan and design a long-term care facility to be constructed in the New Mexico portion of the Fort Defiance chapter of the Navajo Nation in McKinley county

TSA-YA-TOH CHP POWERLINE EXTEND

forty-five thousand dollars (\$45,000) for powerline extensions in the Tsa-Ya-Toh chapter of the Navajo Nation in McKinley county

TSA-YA-TOH CHP VETERANS CTR SITE PREP

twenty-five thousand dollars (\$25,000) to prepare a site for a veterans' center Quonset hut in the Tsa-Ya-Toh chapter of the Navajo Nation in McKinley county

ROCK SPRINGS CHP VETERANS HALL SITE & CONSTRUCT

one hundred twenty-five thousand dollars (\$125,000) to plan, design, construct and prepare the site for the veterans hall in the Rock Springs chapter of the Navajo Nation in McKinley county

CRYSTAL CHP MULTIPRPS FCLTY

one million dollars (\$1,000,000) to plan, design and construct a multipurpose facility, including upgrades to power lines, water systems, roads and lighting, at the Crystal chapter of the Navajo Nation in San Juan county

- to the local government division of the department of finance and administration

GALLUP SOCCER FIELD TRAIL HEAD CONSTRUCT

one hundred thousand dollars (\$100,000) to construct and equip a trail head facility and dog park, including site preparation, at the soccer field in Gallup in McKinley county

GALLUP VETERANS' MEMORIAL CEMETERY

one hundred thousand dollars (\$100,000) to plan, design and construct a veterans' cemetery in Gallup in McKinley county

- to the New Mexico mortgage finance authority

GALLUP AFFORDABLE HOUSING DEVELOPMENT PLAN

sixty thousand dollars (\$60,000) for master planning for an affordable housing development in Gallup in McKinley county pursuant to the provisions of the Affordable Housing Act

- to the department of transportation

WILLIAMS ACRES ROADS IMPROVE

fifty thousand dollars (\$50,000) to plan, design and construct road improvements in Williams Acres in McKinley county

ALLISON RD CORRIDOR IMPROVE DESIGN-GALLUP

five hundred sixty thousand dollars (\$560,000) to design Allison road corridor improvements, including bridge replacement, environmental clearances, right-of-way planning and acquisition and preliminary corridor design, in Gallup in McKinley county

US ROUTE 66 PEDESTRIAN SAFETY IMPROVE

four hundred sixty-four thousand dollars (\$464,000) to plan, design and construct traffic calming and pedestrian safety improvements to downtown United States route 66 in Gallup in McKinley county

DEER SPRINGS RD IMPROVE PLAN-MEXICAN SPRINGS

one hundred thousand dollars (\$100,000) to plan road improvements, including right-of-way acquisition, surveying, clearances, studies and assessments, to Deer Springs road in the Mexican Springs chapter of the Navajo Nation in McKinley county

RED LAKE CHP ROAD TO HEAD START IMPROVE

one hundred thousand dollars (\$100,000) to plan, design, construct and improve the road to the head start facility and the rural road network in the Red Lake chapter of the Navajo Nation in McKinley county

JOHNSON RD/CO RD 55 IMPROVE PLAN-TWIN LAKES

one hundred thousand dollars (\$100,000) to plan road improvements, including right-of-way acquisition, surveys, clearances, studies and assessments, to Johnson road, also known as county road 55, in the Twin Lakes chapter of the Navajo Nation in McKinley county

TWO GREY HILLS CHP RURAL ROAD NETWORK

forty-five thousand dollars (\$45,000) to plan, design, construct and improve a rural road network in the Two Grey Hills chapter of the Navajo Nation in San Juan county
