I request that the following be funded:

RIO ARRIBA CO SENIOR CENTERS EQUIP

one hundred thousand dollars (\$100,000) to purchase and install commercial kitchen equipment, exercise equipment and information technology, including related equipment, furniture and infrastructure, for senior centers countywide in Rio Arriba county

CHAMA SENIOR CTR IMPROVE

one hundred twenty-eight thousand dollars (\$128,000) for interior and exterior improvements, including paving the parking lot, to the Chama senior center in Rio Arriba county

COYOTE SENIOR CENTER ADDITION-RIO ARRIBA CO

three hundred fifty thousand dollars (\$350,000) to plan, design, construct and equip an addition to the senior center in Coyote in Rio Arriba county

DIXON SENIOR CTR CONSTRUCT

one hundred eighty-one thousand one hundred seventy-eight dollars (\$181,178) to plan, design, construct and equip a senior center, including upgrading and expanding the kitchen and paving the parking lot, in Dixon in Rio Arriba county

EL RITO SENIOR CENTER ADDITION

two hundred eighty thousand dollars (\$280,000) to plan, design, construct and equip an addition to El Rito senior center in Rio Arriba county

ESPANOLA SENIOR CENTER IMPROVE

one hundred ninety-one thousand eight hundred eighty dollars (\$191,880) to renovate, equip, expand and pave the parking lot at the Espanola senior center in Rio Arriba county

three hundred twenty-five thousand dollars (\$325,000) to plan, design, purchase, construct and equip improvements, including a concession stand, restroom facilities, a walking track and a drip watering system, at Leonore Martinez memorial park in Tierra Amarilla in Rio Arriba county

RIO ARRIBA CO HOY RECOVERY FCLTY UPGRADE-VELARDE

two hundred six thousand four hundred ninety-two dollars (\$206,492) to design, remodel and upgrade buildings at the Velarde facility of the Hoy recovery program in Rio Arriba county
