I request that the following be funded:

- to the department of environment

LEA CO WATER INFRA/UTILITY SYSTEM IMPROVE

seven hundred twenty-nine thousand dollars (\$729,000) to plan, design and construct water system improvements, including infrastructure and utility improvements, in Lea county

LEA CO WATER TREATMENT FACILITY

four hundred seventy-five thousand dollars (\$475,000) to plan and design a water treatment facility in Lea county

JAL WASTEWATER TREATMENT PLANT IMPROVE

one million dollars (\$1,000,000) to plan, design, construct, equip, purchase and install improvements to the wastewater treatment plant in Jal in Lea county

LOVINGTON WATER SYS RADIO-READ METERS

four hundred fifty thousand dollars (\$450,000) to purchase and install radio-read meters for the water system in Lovington in Lea county

LOVINGTON WELLS CONSTRUCT

four hundred thousand dollars (\$400,000) to plan, design and construct wells in Lovington in Lea county

EUNICE FIRE SUBSTATION CONSTRUCT

eight hundred thousand dollars (\$800,000) to plan, design and construct a fire substation in Eunice in Lea county

LEA CO FAIRGROUNDS FACILITIES IMPROVE

five hundred eighty-five thousand dollars (\$585,000) to construct, purchase and install improvements to facilities, grounds and parking lots at the county fairgrounds in Lovington in Lea county

LEA CO FAIRGROUNDS INFRA IMPROVE

five hundred ninety-five thousand dollars (\$595,000) to design and construct infrastructure improvements, including water and sewer systems and an electrical distribution system, at the county fairgrounds in Lovington in Lea county

NOR-LEA HOSPITAL DIST FLOORING

four hundred thirty-four thousand seven hundred ninety-five dollars (\$434,795) to plan, design, construct, replace and install flooring in the Nor-Lea special hospital district facility in Lovington in Lea county

MAIN STREET ENHANCEMENTS - EUNICE

seven hundred thousand dollars (\$700,000) to plan, design and construct roadway enhancements and safety features on Main street in the vicinity of Avenue L to Avenue O in Eunice in Lea county

four hundred seventy-five thousand dollars (\$475,000) to purchase and install equipment for the energy technology center at New Mexico junior college in Hobbs in Lea county
