24	B. To be elected or appointed as a commissioner, a

2	head, deputy head or division director of a state or local
3	government department responsible for utilities, transportation
4	or construction;
5	(2) having at least five years' experience as
6	<u>a senior manager of a private-sector engineering business or a</u>
7	company regulated by the commission or an advocacy group whose
8	primary interest as specified in its bylaws involves advocacy
9	before the commission or similar regulatory entity; or
10	(3) being licensed in New Mexico as a

5	ethics certificate course provided in person or online by a New

7	complete at least one two-hour ethics course annually.

9	its members [chairman] <u>chair</u> , who shall preside at hearings.
