2 Β. A restricted commercial driver's license issued 3 pursuant to this section shall meet all the requirements of the New Mexico Commercial Driver's License Act, except for a 4 5 knowledge and skills test. A restricted commercial driver's license issued pursuant to this section shall be accorded the 6 7 same reciprocity as a commercial driver's license meeting all 8 of the requirements of the New Mexico Commercial Driver's 9 License Act. The restrictions imposed upon the issuance of the restricted commercial driver's license shall not limit a 10 person's use of the restricted commercial driver's license in a 11 12 noncommercial motor vehicle, nor shall the restricted commercial driver's license affect the division's authority to 13 administer its driver licensing program for operators of 14 vehicles other than commercial motor vehicles. 15

C. The division shall restrict a commercial driver's license issued pursuant to this section as follows:

(1) an applicant shall have a good driving record, as defined in this paragraph. Drivers who have not held a motor vehicle driver's license for at least one year shall not be eligible for the restricted commercial driver's license. Drivers who have been licensed between one and two years shall have a good driving record for their entire driving history. Drivers who have been licensed for more than two years shall have a good driving record for the two most recent .191127.1

For the purposes of this paragraph, "good driving 2 record" means that an applicant: 3 (a) has not had more than one type of driver's license; 4 5 (b) has not had a license suspended, revoked or canceled; 6 7 (c) has not had a conviction, for any type of motor vehicle, for the disqualifying offenses contained 8 9 in Section 66-5-68 NMSA 1978; (d) has not had a conviction, for any 10 type of motor vehicle, for a serious traffic violation; and 11 12 (e) has not had a conviction for a violation of state or local law relating to motor vehicle 13 14 traffic control, other than a parking violation, arising in connection with any traffic accident and has no record of an 15 accident in which the applicant was at fault; 16 a restricted commercial driver's license 17 (2) shall have the same renewal cycle as an unrestricted commercial 18 19 driver's license and shall be limited to a seasonal period or 20 periods as determined by the division; provided that the total number of calendar days in any twelve-month period for which 21 the restricted commercial driver's license is valid does not 22 exceed one hundred eighty days. If the division elects to 23 provide for more than one seasonal period, the restricted 24 commercial driver's license is valid for commercial motor 25 .191127.1
